

SUPPORTING STATEMENT
Application to Pay Off or Discharge an Alien Crewman
Form I-408
(OMB No. 1651-0106)

A. Justification

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

CBP Form I-408, Application to Pay Off or Discharge an Alien Crewman, is used as an application by the owner, agent, consignee, charterer, master, or commanding officer of any vessel or aircraft arriving in the United States to obtain permission from the Secretary of the Department of Homeland Security to pay off or discharge an alien crewman. This form is submitted to the CBP officer having jurisdiction over the area in which the vessel or aircraft is located at the time of application. CBP Form I-408 is authorized by Section 256 of the Immigration and Nationality Act (8 U.S.C. 1286) and provided for 8 CFR 252.1(h). This form is accessible at:

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

CBP uses the information on CBP Form I-408 to make a determination on whether to allow the pay off or discharge of an alien crewman.

- 3. The I-408 is filled out on a conveyance or at the port so it would not be feasible to collect this information electronically.

This information is not duplicated in any other place or any other form.

If this collection were conducted less frequently, CBP would not be able to carry out its responsibilities under Section 256 of the Immigration and Nationality Act.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices; a 60 day notice published on February 28, 2011 (Volume 76, Page 10913) on which no comments were received, and a 30-day notice published on May 10, 2011 (Volume 76, Page 27080) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

Public Cost

The estimated annual public cost is \$707,200. This is based on the number of burden hours associated with this collection (35,360) multiplied (x) the average hourly rate (\$20.00) = \$707,200.

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

The estimated annual cost to the Federal Government associated with the review of these records is **\$592,620**. This is based on the number of responses (85,000) that must be reviewed (x) the time to review and process each response (.166 hours) = 14,110 hours (x) the average hourly rate (\$42.00) = \$592,620.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There are no changes to the information collected.
