Student focus groups will be during the school day or just after school, and focus group sessions will be audio recorded. However, your child's participation in the study is completely voluntary. Your child's participation will not affect whether he or she participates in any classroom activities, and your child will not have to answer any question he or she does not want to, and he or she will be informed of this just prior to participation.

#### **Protection of Information**

Protecting your child's information is very important to us. NASA Office of Education and the companies doing the study will follow strict rules to protect the information your child provides. Your child's name, and the name of your child's teacher or school, will not appear in any reports produced for this study. Your child's answers and records will be kept confidential from NES staff, NASA, your child's school staff, friends, and family.
