Nutrition Services School Questionnaire Content

Breakfast and Lunch Organization

- Breakfast and lunch options offered to students
- Amount of time students have to eat once seated
- Food variety and availability

Food Ordering

- Primary responsibility for deciding which foods to order
- Amount and types of milk offered at the school
- Nutrition services use of produce from a school garden

Food Preparation

- On-site preparation of student meals
- Reduction or substitution of ingredients
- Fat-reducing techniques to prepare meat, poultry, and vegetables
- Use of HACCP-based recipes

Food Variety and Availability

- A la carte items offered
- Availability of butter and salt to students

School Cafeterias

- Capacity of cafeteria during peak meal times
- Provision of nutrition-related education to students
- Training of school cafeteria staff
- Cafeteria inspections
- Use of electronic point of sale system for foods and beverages
- Written crisis response plan for nutrition services program
- Availability of hand-washing or hand-sanitizing stations

School Policy and Environment

School Questionnaire Content

General School Environment

- Student Enrollment
- Student access to free source of drinking water
- Dress codes and identification badges
- Use of personal communication devices, such as cell phones
- School security staff
- Student handbook or code of conduct
- Transportation to and from school
- Joint use agreements

Violence Prevention

- Policies on physical fighting, weapon possession and use, and gang activity
- Student, family, and community involvement in violence prevention efforts
- Policies on bullying and harassment
- Policies on electronic aggression or cyber-bullying

Tobacco Use Prevention

- Policies regarding tobacco use by students, faculty/staff, and school visitors

Alcohol Use Prevention

- Policies regarding alcohol use by students
- Student, family, and community involvement in alcohol use prevention plans

Illegal Drug Use Prevention

- Policies regarding illegal drug possession or use by students
- Student, family, and community involvement in illegal drug use prevention plans
- Student drug testing

Injury Prevention and Safety

- Inspection and maintenance of school equipment

- Seat belt use on school property
- Student, family, and community involvement in injury prevention and safety plans
- Use of safety guidelines in Handbook for Public Playground Safety (elementary schools only)
- Sun safety

Physical School Environment

- Periodic inspection of school physical facilities
- School plans for remediation of lead and PCBs
- Integrated pest management
- Frequency of cleanings, sanitizing, and disinfecting areas within schools
- Indoor air quality
- Purchase of low-emitting products
- Use, storage, and disposal of hazardous materials

Crisis Preparedness and Response

- School plan to address crisis preparedness, response, and recovery
- Training for staff, students, and students' families on crisis preparedness, response, and recovery plans
- Efforts to educate students and parents about crisis preparedness, response, and recovery
- Involvement of students, parents, community agencies, and other community members in the development and evaluation of the crisis preparedness, response, and recovery plan
- School membership in the local emergency planning committee

Family Involvement in the School

Community Service and Service Learning

- Policies requiring students to participate in community service or service learning
- Participation in role model or mentoring programs (e.g., Big Brothers/Big Sisters)

Physical Activity

- Policies regarding recess (elementary schools only)
- Participation in physical activity outside of physical education class
- Walking or biking to or from school

Food and Beverages Available Outside of the School Meal Programs

- Influences on students' dietary behavior while at school
- Types of foods/beverages offered at school events and student parties
- Availability of junk food
- Foods and beverages available in vending machines

- Soft drink sales

School Health Coordination

- School health council, committee, or team
- School staff and local agencies represented in the council
- School health and safety policies and activities
- School improvement plan
- School health coordinator education, training, and responsibilities
