PURPOSE: National Aeronautics and Space Administration (NASA) Johnson Space Center Office of Education (OE) seeks clearance for a focus group to test a web-based form to collect proposals from qualified educational organizations for consideration to participate in an ARISS contact or an In-flight Education Downlink. These activities allow educational organizations to host a live question and answer session with crewmembers aboard the International Space Station. A focus group will:

- enable the collection of information from the public to engage students in the Amateur Radio on the International Space Station (ARISS) and the In-Flight Education Downlink programs to encourage STEM literacy
- validate the estimated time to complete the forms (request to participate/proposals)
- validate that the Information Collection Instruments, as currently designed/formatted, are sufficiently clear and comprehensible
