- 3. Have you ever taken the cave tour?
  - Please tell us about your experience obtaining tickets for the tour.
    - O Were you able to get tickets for the tour times you wanted?
    - O Did you use the phone reservation system?
      - Was it satisfactory? If not, why not?
    - O Is there anything else you want to share about your experience obtaining tickets?

#### Topic Area 3 - FVIS20

- 4. The park is considering changing to an on-line tour ticketing system. Using this system may cause an increase of \$3 per ticket to cover the reservation service fee. If this were to happen, visitors would be able to purchase tickets online replacing the phone system and some tickets would still be available on a first come first served basis.

- 7. Park managers are considering changing the frequency of the cave tours, from every 10 minutes (current) to every 15 minutes (proposed), which would mean fewer tours per day.
  - What is your opinion of this proposed change?

- 8. Have you ever purchased anything at the park concession area?
  - Please tell us about your experience with the park concession services.
  - Please tell us your opinion of the concession service area (e.g., selection, prices, quality, service).
