Report of Diversion

**A. Justification**

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

CBP Form 26, *Report of Diversion*, is used to track vessels traveling coastwise from U.S. ports to other U.S. ports when a change occurs in scheduled itineraries. This form is initiated by the vessel owner or agent to notify and request approval by CBP for a vessel to divert while traveling coastwise from a U.S. port to other U.S. port, or a vessel cleared to a foreign port or place having to divert to another U.S. port when a change occurs in the vessel itinerary. CBP Form 26 collects information such as the name and nationality of the vessel, the expected port and date of arrival, and information about any related penalty cases, if applicable. This information collection is authorized by the Jones Act (46 U.S.C. App. 883) and is provided for 19 CFR 4.91. - 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

CBP uses the information on CBP Form 26 to enforce the provisions of the Jones Act.

Electronic submission of this information is planned as part of the Automated Commercial Environment (ACE) by late 2014.

This information is not duplicated in any other place or any other form.

If the information on CBP Form 26 were collected less frequently, CBP would not be able to enforce the Jones Act.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices including a 60-day notice published on April 6, 2011 (Volume 76, Page 19119) on which no comments were received, and a 30-day notice published on June 20, 2011 (Volume 76, Page 35902) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

There is no PII involved with this information collection.

**Public Cost**

The estimated cost to the respondents is \$4,660. This is based on the estimated burden hours (233) multiplied (x) hourly rate (\$20.00).

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

- 14. Provide estimates of annualized cost to the Federal Government. The estimated annual cost to the Federal Government associated with the review of these records is **\$19,521**. This is based on the number of responses (2,800) that must be reviewed (x) the time to review and process each response (.166 hours) = 464.8 hours (x) the average hourly rate (\$42.00) = \$19,521.

- 15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13 of this Statement.**

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There are no changes to the information collected.

This information collection will not be published for statistical purposes.
