TITLE OF INFORMATION COLLECTION:

Post- Flood Recovery Survey

PURPOSE:

The purpose of the survey is to collect information from communities impacted by Tropical Storm Lee and Hurricane Irene. The survey is part of the Agency’s post-disaster coordination plan with all communities declared in Region 3 during Tropical Storm Lee and Hurricane Irene and will enable the Agency to collect community feedback in an efficient, timely manner, and in accordance with the Agency’s commitment to improve services.

The feedback will provide insights into customer perceptions, experiences and expectations, provide an early warning of issues with service, or focus attention on areas where communication, training or changes in operations might improve delivery of products or services. The information collected will allow for ongoing, collaborative and actionable communications between the Agency and impacted communities. The feedback will contribute directly to the improvement of program management, where applicable.

The information collected from our customers and stakeholders will help ensure that users have an effective, efficient, and satisfying experience with the Agency's programs.

DESCRIPTION OF RESPONDENTS:

The survey will be sent via email to local floodplain administrators and community Chief Executive Officers of local communities of those counties that received a federal declaration during Tropical Storm Lee and Hurricane Irene.

Between those two declarations, the survey will be emailed to 1,500-2,000 communities.


