**TITLE OF INFORMATION COLLECTION:** Building Better Caregivers™ Alumni Community Satisfaction Survey

**PURPOSE:**

The Caregiver Support Program Office, under the Office of Care Management and Social Work Services, has contracted with the National Council of Aging (NCOA) to provide an on-line support community for the Caregivers of Veterans. The on-line community is called “Building Better Caregivers™ (BBC) Alumni Community.”

The BBC Alumni Community is an on-going support community for those Caregivers who have completed the initial 6 week BBC workshop. During participation in the BBC Alumni Community an eight question satisfaction survey will be requested to be completed by the Caregivers participating in the community 8 weeks after they begin participating and thereafter at 1 year intervals.

Satisfaction Survey: Program feedback and other qualitative information gathered from the satisfaction survey will be utilized by the contractor for on-going program development and improvement. The data will be provided to the VA for monitoring of Caregiver satisfaction and program success.

The burden of time and staffing is the responsibility of the contractor.
