Applicants are required to submit copies of letters from both the institution's public and private CRA comment files. Since these files may contain information that is personal in nature and not available for public disclosure, CRA comment letters should be provided to the Regional Director under separate cover. **IF NO SUCH COMMUNICATIONS HAVE BEEN RECEIVED SINCE THE INSTITUTION'S LAST EXAMINATION, THIS SHOULD BE INDICATED IN A SEPARATE LETTER.**
