An individual who knowingly violates this law is subject to a maximum fine of \$250,000 and/or imprisonment for five years. Corporations are subject to a maximum fine of \$1,000,000. [18 U.S.C 1159] For purposes of this law, the term 'Indian' means any individual (1) who is a member of any Indian tribe, band, nation, Alaska Native village, or other organized group or community that is federally recognized, or

(2) who is a member of any Indian group that has been formally recognized as an Indian tribe by a state legislature or by a state commission or similar organization legislatively vested with state tribal recognition authority, or (3) who has been formally certified as an Indian artisan by an Indian tribe.
