I. Funding Opportunity Description

<u>Purpose of Program</u>: The School Climate Transformation grant program provides competitive grants to State educational agencies (SEAs) and local educational agencies (LEAs) to develop, enhance, or expand systems of support for, and technical assistance to, schools implementing an evidencebased, multi-tiered behavioral framework to improve behavioral outcomes and conditions for learning for all students.

<u>Background</u>: Although schools have long attempted to address discipline, disruptive and problem behavior, violence, and bullying, the vast majority of our Nation's schools have not implemented comprehensive, effective supports addressing the full range of students' social, emotional, and behavioral needs.¹

A report issued by the U.S. Secret Service and the Department of Education after the Columbine shooting found that one of the best things schools can do to reduce violence and bullying is to improve a school's climate and increase trust and communication between students and staff. Research demonstrates that the implementation of an evidence-based multi-tiered behavioral framework, such as Positive Behavioral Interventions and Supports (PBIS), can

help improve overall school climate and safety. A key aspect of this multi-tiered approach is that it provides differing levels of support and interventions to students based on their needs: certain steps involve the whole school (like consistent rules, consequences, and reinforcement of appropriate behavior), with more intensive steps for groups of students exhibiting at-risk behavior, and individualized services for students who continue to exhibit troubling behavior.

When a multi-tiered behavioral framework has been implemented with fidelity, studies have found the following statistically significant results: an increase in perceived school safety, reductions in overall problem behaviors, reductions in bullying behaviors², and reductions in office discipline referrals and suspensions³. Studies have also found a correlation between the use of these procedures and improved social skills.⁴ Emerging evidence also links the implementation of a multi-tiered behavioral framework with

improved academic achievement.⁵ In addition to being effective, such school-wide programs are attractive to SEAs and LEAs because they are designed to enhance the learning environment for all students while having additional supports in place for students who have greater social, emotional, and behavioral needs.

Under this program, grant funds will help school districts to develop and adopt, or expand to more schools, a multi-tiered behavioral framework that guides the selection, integration, and implementation of the best evidence-based behavioral practices for improving school climate and behavioral outcomes for all students. Elsewhere in this edition of the <u>Federal Register</u> we announce a competition for state educational agencies that will help support them in a similar way.

In the following sections, we announce priorities and requirements for this competition.

<u>Priorities</u>: We are establishing this priority for the FY 2014 grant competition and any subsequent year in which we make awards from the list of unfunded applicants from this competition, in accordance with section 437(d)(1) of the

General Education Provisions Act (GEPA), 20 U.S.C. 1232(d)
(1).

<u>Absolute Priority</u>: This priority is an absolute priority. Under 34 CFR 75.105(c)(3) we consider only applications that meet this priority.

This priority is:

<u>Grants to Local Educational Agencies to Support the</u> <u>Implementation of Multi-Tiered Behavioral Frameworks to</u> <u>Improve School Climate</u>.

This priority supports grants to LEAs to develop, enhance, or expand systems of support for, and technical assistance to, schools within the LEA implementing a multitiered behavioral framework to improve conditions for learning and behavioral outcomes for all students. <u>Program Requirements</u>: The following requirements apply to projects funded under this competition: Each grantee must implement a plan that--

 Builds capacity for sustained, school-wide implementation of a multi-tiered behavioral framework;

(a) Improves the skills of school personnel to organize the components of a multi-tiered behavioral framework, such as discipline policies, funding, professional development, coaching, and interagency coordination for service provision;

(b) Develops a cadre of trained and experienced staff
 to provide training and ongoing coaching to school
 leadership teams on the multi-tiered behavioral framework;

(c) Improves the quality, accessibility, and usefulness of individual school and LEA data collection and analysis;

2. Enhances capacity by providing training and technical assistance to schools on:

(a) Developing or improving the quality,
 accessibility, and usefulness of data collection, using
 applications such as the School Wide Information System
 (SWIS) or similar information systems, and data-based
 decision making;

(b) Improving the skills and expertise of school personnel to develop, implement, and sustain a multi-tiered behavioral framework;

(c) Use of evidence-based practices and reliable and valid tools and processes for evaluating the fidelity of the implementation of a multi-tiered behavioral framework and for measuring its outcomes, including reductions in discipline referrals, suspensions, expulsions, the use of restraints and seclusion and improvements in school climate, time spent in instruction, and overall academic achievement;

(d) Developing and implementing a process to review and update district student codes of conduct, based, in part, on both internal and community input, to support the implementation of a multi-tiered behavioral framework; and

(e) Coordinating school efforts with appropriateFederal, State and local resources.

3. This plan must include an assurance that the applicant will work with a technical assistance provider, such as the U.S. Department of Education-funded PBIS Technical Assistance Center, that will provide technical assistance related to implementing program activities. <u>Application Requirements</u>: The following requirements apply to all applications submitted under this competition. Applications that fail to meet any one of these requirements will not be read or scored. In their application, an applicant must--

(a) Describe the current implementation effort and emerging need to implement, scale-up, and sustain a multitiered behavioral framework, and present applicable data demonstrating this need, including, but not limited to, the number of participating schools that are currently implementing a multi-tiered behavioral framework and want to scale-up and sustain, and the number of schools that are

interested in implementing a multi-tiered behavioral
framework;

(b) Describe the plan to build, improve or enhance LEA and individual school capacity to provide effective training, technical assistance, and support to schools and staff on implementing a multi-tiered behavioral framework, including how applicant will assess readiness for implementation and build capacity at each participating school;

(c) Describe how the needs of high-need schools will be addressed, including high-poverty schools, low-performing schools including persistently lowest-achieving schools, and priority schools (in the case of States that have received the Department's approval of a request for flexibility under the Elementary and Secondary Education Act of 1965, as amended (ESEA));

(d) Conduct a district assessment of any disproportionate discipline and expulsions of minority students or students with disabilities, and develop a detailed plan during the grant period that will promote fair and effective disciplinary practices; and

(e) Explain how its efforts will be linked to other school safety, school improvement, or school reform efforts.

<u>Definitions</u>: We are establishing these definitions for the FY 2014 grant competition and any subsequent year in which we make awards from the list of unfunded applicants from this competition, in accordance with section 437(d)(1) of GEPA, 20 U.S.C. 1232(d)(1).

<u>High-need LEA</u> means an LEA (a) that serves not fewer than 10,000 children from families with incomes below the poverty line; or (b) for which not less than 20 percent of the children served by the LEA are from families with incomes below the poverty line.

<u>High-poverty school</u> means a school in which at least 50 percent of students are eligible for free or reduced-price lunches under the Richard B. Russell National School Lunch Act or in which at least 50 percent of students are from low-income families as determined using one of the criteria specified under section 1113(a)(5) of the Elementary and Secondary Education Act of 1965, as amended (ESEA). For middle and high schools, eligibility may be calculated on the basis of comparable data from feeder schools. Eligibility as a high-poverty school under this definition is determined on the basis of the most currently available data (www2.ed.gov/legislation/FedRegister/other/2010-4/121510b.html).

<u>Multi-tiered behavioral framework</u> means a school-wide structure used to improve the integration and implementation of behavioral practices, data-driven decision-making systems, professional development opportunities, school leadership, supportive SEA and LEA policies, and evidencebased instructional strategies.

<u>Persistently lowest-achieving schools</u> means, as determined by the State—

(1) Any Title I school in improvement, corrective action, or restructuring that—

(i) Is among the lowest-achieving five percent of Title I schools in improvement, corrective action, or restructuring or the lowest-achieving five Title I schools in improvement, corrective action, or restructuring in the State, whichever number of schools is greater; or

(ii) Is a high school that has had a graduation rate as defined in 34 CFR 200.19(b) that is less than 60 percent over a number of years; and

(2) Any secondary school that is eligible for, but does not receive, Title I funds that—

 (i) Is among the lowest-achieving five percent of secondary schools or the lowest-achieving five secondary schools in the State that are eligible for, but do not receive, Title I funds, whichever number of schools is greater; or

(ii) Is a high school that has had a graduation rate as defined in 34 CFR 200.19(b) that is less than 60 percent over a number of years.

(b) To identify the lowest-achieving schools, a State must take into account both—

(i) The academic achievement of the "all students" group in a school in terms of proficiency on the State's assessments under section 1111(b)(3) of the ESEA in reading/language arts and mathematics combined; and

(ii) The school's lack of progress on those assessments over a number of years in the "all students" group.

For the purposes of this priority, the Department considers schools that are identified as Tier I or Tier II schools under the School Improvement Grants Program (see 75 FR 66363) as part of a State's approved FY 2009, FY 2010, or FY 2011 application to be persistently lowest-achieving schools. A list of these Tier I and Tier II schools can be found on the Department's Web site

at www2.ed.gov/programs/sif/index.html.

<u>Priority school</u> means a school that has been identified by the State as a priority school pursuant to the State's approved request for ESEA flexibility.

<u>Waiver of Proposed Rulemaking</u>: Under the Administrative Procedure Act (5 U.S.C. 553), the Department generally

offers interested parties the opportunity to comment on proposed priorities, definitions, and requirements. Section 437(d)(1) of GEPA, however, allows the Secretary to exempt from rulemaking requirements, regulations governing the first grant competition under a new or substantially revised program authority. This is the first grant competition for the School Climate Transformation Grant Program and therefore qualifies for this exemption. In order to ensure timely grant awards, the Secretary has decided to forgo public comment on the priorities, definitions, and requirements under section 437(d)(1) of GEPA. These priorities, definitions, and requirements will apply to the FY 2014 grant competition and any subsequent year in which we make awards from the list of unfunded applicants from this competition.

Program Authority: 20 U.S.C. 7131.

<u>Applicable Regulations</u>: (a) The Education Department General Administrative Regulations (EDGAR) in 34 CFR parts, 75, 77, 79, 80, 81, 82, 84, 85, 97, 98, and 99. (b) The Education Department suspension and debarment regulations in 2 CFR part 3485.

II. Award Information

<u>Type of Award</u>: Discretionary grants.

Estimated Available Funds: \$22,125,000.

Contingent upon the availability of funds and the quality of applications, we may make additional awards in FY 2015 from the list of unfunded applicants from the competitions announced in this notice.

Estimated Range of Awards: \$100,000 to \$750,000 per year for up to 5 years.

Estimated Average Size of Awards: \$200,000.

<u>Maximum Award</u>: \$750,000.

Estimated Number of Awards: 110.

<u>Note</u>: The Department is not bound by any estimates in this notice.

<u>Project Period</u>: Up to 60 months.

III. Eligibility Information

1. <u>Eligible Applicants</u>: LEAs, or consortia of such LEAs, as defined by section 9101(41) of the ESEA.

2. <u>Cost Sharing or Matching</u>: This program does not require cost sharing or matching.

3. Participation by Private School Children and

<u>Teachers</u>. Section 9501 of the ESEA requires that SEAs, LEAs, or other entities receiving funds under the Safe and Drug-Free Schools and Communities Act provide for the equitable participation of private school children, their teachers, and other educational personnel in private schools located in geographic areas served by the grant recipient.

In order to ensure that grant program activities address the needs of private school children, the applicant must engage in timely and meaningful consultation with appropriate private school officials during the design and development of the proposed program. This consultation must take place before the applicant makes any decision that affects the opportunities of eligible private school children, teachers, and other educational personnel to participate in grant program activities.

However, the page limit does apply to all of the application narrative section.

Our reviewers will not read any pages of your application that exceed the page limit.
