Section 1860 D-14 of the Social Security Act, as amended, authorizes us to collect the information contained on this form. We will use the information to conduct a quality review of applications and determine if we made the correct decision during the review process for those applicants who requested additional assistance with the costs of the Medicare prescription drug plan. Your responses are voluntary. However, failure to provide all or part of the requested information may affect our ability to evaluate our decision for additional assistance with the Medicare prescription drug plan.

We rarely use the information provided on this form for any other purpose other than the reasons explained above. However, we may use it for the administration and integrity of Social Security programs. We may also disclose information to another person or to another agency in accordance with approved routine uses, which include, but are not limited to the following:

- 1. To enable a third party or agency to assist Social Security in establishing rights to Social Security benefits and/or coverage.
- 2. To comply with Federal laws requiring the release of information from Social Security records (e.g., to the Government Accountability Office and Department of Veterans' Affiars);
