<p>The Beginning Teacher Longitudinal Survey (BTLS) follows a sample of public school teachers who were in their first year of teaching in 2007-08. These teachers were first interviewed as part of the 2007-08 Schools and Staffing Survey (SASS) and were also part of the 2008-09 Teacher Follow-up Survey (TFS). They have been contacted again in 2010 as part of a second follow-up, and will be contacted in 2011 and 2012 as part of a third and fourth follow-up. Following this small subset of the SASS sample for at least a decade will provide much needed data on teachers' careers, attrition, and mobility. This submission provides (1) a summary of informed consent use in longitudinal studies (see the attached BTLS Informed Consent Memo 2010-08-16.doc), which fulfills the Office of Management and Budget (OMB) terms of clearance for the Beginning Teacher Longitudinal Study (BTLS; OMB# 1850-0868 v.1); (2) a summary of the incentive experiment results conducted as part of the approved BTLS 2009 third wave (see the attached BTLS 2009 Incentive Experiment Results.docx); (3) a summary of changes to the study's recruitment and data collection materials to be used in BTLS 2010 and 2011 (4th and 5th waves; see the attached BTLS 2009-2012 Supporting Statement Appendix B.doc), resulting from findings described in the BTLS Informed Consent Memo and from preliminary results of BTLS 2010; (4) proposed use of a \$20 incentive in BTLS 2010 and 2011 (4th and 5th waves) based on the results of the incentive experiment (see the attached BTLS 2009 Incentive Experiment Results.docx); and (5) a proposal to conduct a recruitment video experiment in BTLS 2010 (4th wave) to evaluate whether the</p>
