SUPPORTING STATEMENT FOR PAPERWORK REDUCTION ACT 1995 SUBMISSIONS

A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

Prior to the enactment of the Taxpayer Relief Act of 1997 (Pub. L. 105-34, August 5, 1997) (TRA '97), section 104(a) of the Employee Retirement Security Act of 1974 (ERISA) required administrators of employee benefit plans automatically to file the plan's summary plan description (SPD) and any summaries of material modification (SMMs) with the Secretary of the Department of Labor (the Department). TRA '97 eliminated the requirement that these documents be filed automatically with the Department, but added ERISA section 104(a)(6), requiring a plan administrator to furnish documents related to an employee benefit plan to the Department upon request. The requirement that administrators furnish the Department requested plan documents other than SPDs and SMMs was part of section 104(a) (6) and consolidated with the new furnishing requirement pertaining to SPDs and SMMs. The rule implementing the requirement to furnish SPDs and SMMs on request was finalized on January 7, 2002 (67 FR 777, 784), and has not been amended since that time. See 29 CFR 2520.104a-8.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

The SPD, SMM, and other plan documents covered by the rule provide information to participants and beneficiaries about their rights and benefits under their employee benefit plans. Although Congress, in TRA '97, eliminated the requirement to file the SPD and SMMs automatically with the Department, Congress simultaneously added section 104(a)(6) to ERISA, authorizing the Department to request from an employee benefit plan "any documents relating to the employee benefit plan" that describe how the plan is established or operated. Pursuant to its regulation, the Department requests documents under Section 104(a)(6) when a participant or beneficiary has previously requested the documents directly from the plan administrator and the administrator has failed or refused to provide them. The Department therefore uses the requested information to respond to participants' requests to the Department for documents that the participants were unable to obtain from their plan administrators. Prior to elimination of the filing requirement, the Department was able to satisfy many of these public requests for assistance with plan documents by supplying copies of the SPDs filed with the Department and maintained in the Public Disclosure Room.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information

technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration for using information technology to reduce burden.

The collection of this information may be satisfied electronically if the plan maintains the documents electronically and the participants are able to receive the documents electronically. Most plan administrators maintain printed copies of these documents even if they normally distribute them electronically. The Department encourages and accepts electronic furnishing of requested documents and has assumed for purposes of this burden estimation that 38 percent of plan administrators will supply electronic copies of requested documents. The remaining 62 percent of plan administrators are assumed to prefer for their own recordkeeping purposes to continue to supply printed documents to the Department from their existing printed stock. The Department expects to continue to promote the use of information technology as a means of increasing the timeliness of responses and to reduce the cost and time burdens for respondents.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

This request for documents is not duplicated in any other Federal statute or regulation. Employee benefit plans are required by other statutory provisions to disclose certain plan information to participants. Section 104(a)(6) and the related regulation therefore contemplate that respondents will need merely to provide copies of documents that were previously prepared and are available pursuant to other statutory or regulatory requirements. The Department requests documents pursuant to 104(a)(6) and this rule when a participant or beneficiary requests assistance from the Department because he or she has been unable to obtain the document directly from the plan administrator.

The Department collects documents related to the establishment or operation of an employee benefit plan in order to provide participants and beneficiaries with plan information that they have requested and to which they are entitled under the disclosure requirements of ERISA. The collection is conducted as frequently as is necessary to provide technical assistance to plan participants and beneficiaries.

7. Explain any special circumstances that would cause an information collection to be conducted in a

manner:

- requiring respondents to report information to the agency more often than quarterly;
- requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
- requiring respondents to submit more than an original and two copies of any document;
- requiring respondents to retain records, other than health, medical, government contract, grantin-aid, or tax records for more than three years;
- in connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;

- requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

The Department's Notice of Proposed Extension of Information Collection Request for Furnishing Documents to the Secretary of Labor on Request Under ERISA Section 104(a)(6) was published in the Federal Register on May 24, 2011 (76 FR 30199). No comments were received.

The burden hours attributable to this collection consist of those hours necessary for a plan administrator to assemble existing information when requested by the Department on behalf of an employee benefit plan participant or beneficiary and to forward the information to an address specified in the request. The information generally consists of plan documents such as SPDs or SMMs, which have been prepared previously to comply with other statutory requirements, such as ERISA disclosure provisions. The annual burden of complying with the Department's request is estimated at 22 hours with an equivalent cost of \$810.

Based on document recovery data from the Department's Office of Participant Assistance, the Department has estimated that the number of requests the Department made to plan administrators for SPDs and SMMs under section 104(d)(6) of the rule is approximately 300. This number is based on the number of requests the Department has received the last few fiscal years. Thus, 300 total respondents may be required annually to provide responses for purposes of this ICR. The Department has further assumed that 98 percent of the respondents (294 respondents) will respond promptly and fully to the Department's request when it is first received and that 38 percent of those 294 respondents (112 respondents) will provide the requested documents electronically. Because such requests pertain only to existing plan documents, the Department estimates that assembling the documents for mailing to the Department for the 182 respondents that do so in a timely manner will take approximately five minutes per respondent, resulting in an annual hour burden of 15.2 hours. Assuming a clerical professional prepares the documents, this will result in \$430 in equivalent cost burden (\$28.21/hour x 15.2 clerical hours).¹ The 112 respondents who reply electronically in a timely manner are estimated to take only two minutes each, since attaching electronic documents to an e-mail takes less time than collecting paper copies for mailing, resulting in an additional annual hour burden of approximately 3.7 hours and equivalent cost burden of approximately \$110 (\$28.21/hour x 3.7 hours). The remaining 2 percent of respondents (6 respondents) who do not respond to a Departmental request in a timely fashion, either intentionally or for reasons beyond their control, will choose instead to supply an explanation and file a penalty waiver request. The Department estimates that it will require 30 minutes of each of these respondents' time to prepare such an explanation and waiver request and assemble it for mailing, creating an annual hourly burden of five hours. It is assumed that a benefits manager will prepare the documentation at a cost of \$93.31/hour, thus generating an equivalent cost burden of \$280 (\$93.31/hour x 3 hours) on plans that do not respond in a timely fashion. The total annual hour burden estimated for employee benefit plans is thus approximately 22 hours (15.2 hours for plans submitting by mail in a timely manner + 3.7 hours for plans submitting electronically + 3 hours for plans that are late in responding) and equivalent cost burden is approximately \$810 $($430 + $110 + $280).^2$

13. Provide an estimate of the total annual cost burden to respondents or recordkeepers resulting from the collection of information. (Do not include the cost of any hour burden shown in Items 12 or 14).

The documents that the Department requests pursuant to this rule have previously been created and maintained by the plan administrator in order to fulfill other statutory provisions, such as ERISA reporting or disclosure requirements. Therefore, there are no start-up costs

ascribed to the collection of the information under section 104(a)(6) and this regulation,. The only additional cost for providing this information to the Department is the cost for assembling and mailing to the Department the requested plan documents. The Department has assumed that annually 38 percent of all respondents, including those that file an explanation and penalty waiver request, (114 respondents) will file plan documents electronically and that the remaining 186 respondents will choose to provide the requested documents by mail. The Department has not attributed any additional cost burden to electronic transmission of the documents and has estimated mailing costs at \$7.00 per mailing (\$4.95 for the cost of priority mail, and \$2.05 to print a 40 page SPD and cover sheet which is estimated to cost \$.05/page). Thus, this will total \$1,300 (\$7.00 x 186) for those plans. Four of the six plans that file late are expected to submit paper documents. These plans are expected to require an additional four pages to file an explanation and penalty waiver (costing \$0.20 more for those plans). Based on the Department's estimate of an annual 300 requests to plan administrators, the annual cost burden to respondents for distribution is approximately \$1,300.

14. Provide estimates of annualized cost to the Federal government. The annualized cost to the Federal government has been estimated based on the expected number of requests that the Department will make annually for plan documents (300) and the current processes in place to make and handle such requests. It is assumed that the Department will use form letters to make all of its initial requests for plan documents and conduct all interactions by mail.³ Based on current procedures, the form letters require an average of ten minutes of clerical staff time at GS-6 (step 5) level, whose wage, salary and overhead costs are estimated at \$36.30/hour). Thus, 300 letters will be sent at a cost of \$0.49 for the stamp and piece of paper (\$0.44+\$0.05) at a cost of \$147 (300 letters x \$0.49), plus this will impose \$1,815 in labor costs (300 x 0.167 hours x \$36.30). For the 2 percent of respondents who annually do not promptly and fully respond to the Department's initial request, the Department will send additional follow-up correspondence addressing the issue of noncompliance that will also take 10 minutes of the secretary's time. This amounts to an additional 6 letters which will cost \$2.94 for material costs ((\$.44 per stamp + \$.05 per page) x 6 letters) and \$36 in labor costs (36.30/hour x (0.167 hours per plan) x 6 plans). The total annual labor and material costs to the Federal government is therefore estimated at \$2,000 (\$1,850 in labor costs and \$150 in material costs).

15. Explain the reasons for any program changes or adjustments reporting in Items 13 or 14 of the OMB Form 83-I.

The estimated number of requested SPDs and SMMs has been adjusted to incorporate recent recovery data from the Department's Office of Participant Assistance. The 2008 estimate for requested documents was 500, but data from the last 3 years indicates that the number of requests for SPDs and SMMs are closer to 300 annually. The estimates above also reflect updated postage and material costs and wage rates. The hour burden now includes an equivalent cost estimate for workers' time and overhead. Another modification is that the Department now estimates that 38 percent of filings are done electronically compared to 10 percent as was previously done.
