

In-House Introduction

- Thank you for coming in today. Before we begin, have you participated in one of our studies before? (a *yes* answer reduces the amount of general background information about the purpose of lab studies and BLS that is provided).
- <u>Background</u>. Let me give you some background for what you will be doing today. The Bureau of Labor Statistics, or BLS, would like to make it as easy as possible for people to find information on its website. Therefore, I am going to ask you to search for some information on the BLS website. You will be presented with a series of tasks and asked to search for a specific section on the website or find information to answer a question.
- Now this next point is important. It's easy to think that we're evaluating you because we're going to ask you to complete tasks, and I'll be watching, but we're really not evaluating you. We're evaluating the website. We might have done a great job designing the website, or we might have done a poor job. The only way we can find out is to have a wide variety of people use it. So, please keep that in mind. We are not evaluating you. So relax and try to have fun today.
- Also, when some people come into our lab, they view whatever we ask them to do as a personal challenge, and they really want to do their best. That's a good attitude up to a point, but what we're trying to do is simulate what you would do if you were at home, or somewhere else, and you came to the BLS website to find some information. We want you to try as hard as you would if you were at home, but if you reach a point where if you were at home you would just skip the task and go to another website, please do that.
