The Family Unity Program provides a transition for certain family members of legalized aliens to family-sponsored second preference immigrant status. This is evident not only from section 301 of IMMACT, but also from its interrelationship with section 112 of IMMACT, which created visa numbers for spouses and children of eligible legalized aliens under the family-sponsored second preference classification.
