1. All responses should be TYPED or PRINTED with an ink pen. Sign in ink the signature block on the back of the form. Any additional sheets must be attached to the renewal form and write name, address, and social security number at the top of each page. Identify the question being answered on each attached sheet.
2. Issuance of your license will be delayed if the fee is not included or incorrect, or if the form is incomplete or otherwise improperly prepared.
3. This is a renewal application for a collector of curios and relics license. Upon approval, the license will entitle you to acquire firearms, classified as curios or relics, in interstate or foreign commerce. You may dispose of curios and relics to any person, not otherwise prohibited by the Gun Control Act of 1968, residing within your state, and to any other Federal firearms licensee in any state. It must be emphasized that the collector's license being applied for pertains exclusively to firearms classified as curios and relics, and its purpose is to facilitate a personal collection. you may **NOT** engage in the business of buying and selling curios and relics under this license.
4. A Certificate of Compliance (ATF Form 5330.20) must be included for all new Responsible Persons being added to the license with submission of this renewal application. A Certificate of Compliance is not needed for any existing Responsible Persons. This form can be obtained at www.atf.gov/forms or by contacting the ATF Distribution Center at (202)648-6420.
5. Applicants must submit a copy of the completed renewal application to the Chief Law Enforcement Officer (CLEO) of the locality in which the premises sought to be licensed are located. Item C4 requires certification that the CLEO has been notified.
6. A license issued under 18 U.S.C. Chapter 44: is **NOT** a license to carry, use, or possess a firearm; and confers **NO** right or privilege to conduct an activity contrary to state or other law.
7. The certification of the renewal form must be signed by the owner, a partner, or in the case of a corporation, association, etc., by an officer duly authorized to sign for the applicant.
8. In most cases, ATF will contact you prior to issuance of a license. If you do not qualify for renewal, you will be advised in writing of the reasons for denial and your renewal application fee will be refunded.
9. Applicants intending to engage in the firearms business are required to be licensed under 18 U.S.C. 923. Such persons need to complete ATF Form 7. Contact the Federal Firearms Licensing Center at (866)662-2750 for further information.

1. **Authority.** Solicitation of this information is authorized pursuant to 18 U.S.C. 923 (a) of the Gun Control Act of 1968. 2. **Purpose.** To determine the eligibility of the applicant to obtain a Collector's License, the ownership of the activity, and the identity of the responsible persons in the activity.
3. **Routine Uses.** The information will be used by ATF to make determinations set forth in paragraph 2. In addition, information may be disclosed to other Federal, State, foreign, and local law enforcement and regulatory agency personnel to verify information on the application and to aid in the performance of their duties with respect to the enforcement and regulation of firearms and/or ammunition where such disclosure is not prohibited by law. The information may further be disclosed to the Justice Department if it appears that the furnishing of false information may constitute a violation of Federal law. Finally, the information may be disclosed to members of the public in order to verify the information on the application when such disclosure is not prohibited by law.
