Instructions for Reporting by Occupation

 Report employees in the occupations in which they are working, not in occupations for which they have been trained. For example: An employee trained as an engineer, but working as a drafter,

should be reported as a drafter.

- · Report each employee only once in the occupation that requires the highest level of skill if the employee performs work in two or more occupations. If there is **no** measurable difference in skill requirements, report employees in the occupation in which they spend the most time.
- Use the description of duties along with the job titles to determine where to place employees. Do not rely on job titles alone.
- Report apprentices and trainees in the job for which they are being trained. Report helpers separately because they are not in training for the occupation they are helping.
- Report part-time workers in the job they perform.
