Purpose Passport Services has developed a comment card that acceptance agencies and passport centers will distribute to attendees at outreach events to obtain their feedback on whether they were satisfied with the information presented. The results will assist Passport Services in improving its outreach campaigns. Passport Services participates in a variety of outreach events including travel shows, naturalization ceremonies, study abroad fairs, conferences, etc. Representatives from Passport Services generally staff a small booth and/or table at these events and distribute informational brochures and flyers to participants. They often answer questions about the passport application process and the Department of State's smart traveler programs. Some of the outreach events are passport application acceptance events where staff will take passport applications on-site.

Description of Respondents Respondents will include anyone who stops at the Passport Services booth/table at an outreach event and agrees to complete the comment card. These individuals will have an interest in learning more about passports as they are generally people who travel internationally for business, and/or pleasure.
