GENERAL INFORMATION

- A The United States Department of Agriculture (USDA) provides End-Use Certificate for Wheat (FSA-750) for persons required to submit these certificates for the importation of Canadian-produced wheat into the United States.
- B Regulations governing the End-Use Certificate Program can be found at 7 CFR Part 782.
- C Wheat covered by an End-Use Certificate for Wheat must be stored identity preserved until such time as the wheat is loaded onto a conveyance for delivery to an end user or foreign country.
- D Copies of FSA-751, Canadian Wheat Consumption and Resale Report, can be obtained from the Kansas City Commodity Office, Contract Reconciliation Division, P.O. Box 419205, Kansas City, MO 64141-6205.
- E FSA-751, Canadian Wheat Consumption and Resale Report must be filed by each end user, subsequent buyer, exporter, and importer.
- F All filers must complete Part A, General Information.
- G In Item 5, enter the serial number from the FSA-750, End-Use Certificate for Wheat, that was filed when the Canadian wheat was imported.
- H End users and exporters must:
 - (1) complete Part B, Certification by End Users and Exporters.
 - (2) file form FSA-751 to report quarterly consumption and exports. Reports are due from end users and exporters within 15 workdays following March 31, June 30, September 30, and December 31.
- I Subsequent buyers and importers must:
 - (1) complete Part C, Certification by Subsequent Buyers and Importers.
 - (2) file form FSA-751 for each individual sale. Reports are due from subsequent buyers and importers within 15 workdays following the date of the sale.
