Pursuant to Sections 366.1 and 366.4(a) of the Federal Energy Regulatory Commission's ("Commission") rules and regulations,¹ Brookfield Asset Management Inc. ("Brookfield"), BPC Holdings Inc., Carena Holdings Limited, Placements la Rondelle Ltee, Brascan US Holdings Inc., Brookfield US Corporation (formerly Brascan (US) Corporation), and Katahdin Holdings LLC (together, the "Brookfield Katahdin Family"), respectfully notifies the Commission that each of the Brookfield Katahdin Family companies continue to be a "holding company" within the meaning of 18 C.F.R. § 366.1² and provides the following information as required by 18 C.F.R. § 366.4(a):³

² The Brookfield Katahdin Family submitted their original Notification in Docket No. HC06-1-000 on June 15, 2006. Listed here are only those holding companies required to file Form FERC-65. There are additional Brookfield companies that meet the definition of a "holding company" under the Public Utility Holding Company Act of 2005, but these are automatically exempt from filing Form FERC-65 or Form FERC-65A. Nonetheless, these companies are listed in **Appendix A**. In *Order No. 667-A*, the Commission explained that holding companies that were "holding companies" solely by reason of their exempt wholesale generator ("EWG") status, qualifying facilities ("QF"), and foreign utility company ("FUCO") holdings, were not required to file Forms FERC-65 or FERC-65A. *Repeal of the Public Utility Holding Company Act of 1935 and Enactment of the Public Utility Holding Company Act of 2005, Order No. 667-A*, at P 36, 71 Fed.
