A. Justification for Agency Form No.: SBA Form 1222 and SBA Form 1224

SBA Form 1222 ---- "Notice of Award" (NOA). The Federal Grant and Cooperative Agreement Act of 1977, requires each agency to use a grant or cooperative agreement as evidence of the legal relationship between the agency and the recipient of financial assistance from the agency. The Small Business Administration (SBA) uses this form as such evidence and as a formal notification of a grant award or a cooperative agreement award for the various financial assistance programs funded by the SBA. The SBA identifies grant awards on this form when the Agency does not anticipate substantial involvement with the recipient during performance. This form also functions as a cooperative agreement award when substantial involvement by SBA is anticipated with the recipient during performance. Section G. 10. Reporting and Record Keeping Requirements of the NOA includes a number of reporting requirements that are necessary to document the expenses of the award recipients, to verify that the recipient has agreed to be responsible for government funds and that the money is spent appropriately.

SBA Form 1224 --- "Grant/Cooperative Agreement Cost Sharing Proposal." The SBA's Office of Small Business Development Center (OSBDC) and the Office of Women's Business Center (WBC) use this form to verify the recipient's share of the project cost. The project cost may include but is not limited to cash and third-party in-kind contributions. The collection of this form is necessary to specify the dollar value and/or percentage share of the cost contributed by the recipient and obtain the recipient's certification that it will meet the criteria for cost sharing or matching as outlined in the applicable Office of Management and Budget Circular and/or SBA regulations (i.e., Administrative Requirements – 2 CFR Part 215 (OMB Circular A-110) and/or 13 CFR Part 143).

The information described in #1 above is used to oversee and evaluate the recipient's programmatic and financial performance and to ensure compliance with the NOA terms and conditions. The information is also used to report in the aggregate, the accomplishments of the SBDC Program to Congress and OMB for budget planning purposes. The information is used by the SBA programs on behalf of the Administrator, Grant/Cooperative Agreement Recipient representatives, Project Director, Lead SBDC Director, Assistant Directors, Accountants, Dean/Provost of the education institution, Certifying Financial Officers, Executive Directors, SBDC Project Officer, Grants Management/Agreement Officers, SBA Technical Representatives, Program Managers, District Directors, Regional Administrators, Financial examiners and auditors. The SBA has used this information for the purpose of determining

whether the goals and objectives as specified in the Small Business Act are met, and whether the tax-payers monies are spent properly and in support of the program.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. The use of automated, electronic, mechanical, or other technological collection techniques are used in a variety of ways to organize and prepare the collection of information. The program announcement requires the recipient to submit proposals electronically through www.grants.gov. All forms are available on the internet for client use. Form 1224 is collected electronically. SBA is required to obtain original signatures on Form 1222. However, the reports that are required by Form 1222 are frequently submitted electronically. In an effort to comply with Government Paperwork Elimination Act and the E-Gov Initiative, SBA is working on expanding the use of electronic information collection. Electronic submission reduces the burden of responses by eliminating duplication of effort between report periods.

4. <u>Describe efforts to identify duplication. Show specifically why any similar information already</u> <u>available cannot be used or modified for use for the purposes described in Item 2 above.</u>

The forms do contain minimal duplication (such as name, address, etc.) to facilitate identification of the client but the focus is on the reporting requirements. Additionally, while subsequent reports may require the same type of information, each set of data is unique to the reporting period.

The reports are prepared by the various SBA program recipients, which include for-profit, nonprofit, universities, colleges, state government. The data collected does not impact small businesses directly. Special care is taken to limit inquiries to only necessary information when small businesses are asked to respond to SBA Form 1222. Only universities, colleges and statesponsored government agencies fill out SBA Form 1224.

6. <u>Describe the consequence to Federal program or policy activities if the collection is not</u> <u>conducted or is conducted less frequently, as well as any technical or legal obstacles to reduce</u> <u>burden.</u>

The data being collected is required by regulations or OMB Circulars and if not collected or was collected less frequently than stipulated in the NOA, SBA would not have the information necessary to determine the grant recipient's compliance with the terms and condition of the NOA and would be in violation of those regulations or circulars. Further, if the information is not collected, SBA's ability to evaluate its various award programs would be greatly impaired.

7. <u>Explain any special circumstances</u>. <u>Explain any special circumstances that would cause an</u> information collection to be conducted in a manner etc.

No special circumstances exist.

SBA published a notice in the Federal Register on December 12, 2011 at 76 FR 77298. No comments were received.

SBA will not provide any payment or gift to respondents, other than re-enumeration of contractor or grantees.

Any confidential or sensitive information that is collected will be protected from disclosure to the extent permitted by law, including the Freedom of Information Act, 5 USC 552 and the Privacy Act, 5 USC 552a. In addition, the Agency restricts access to the information collected to those personnel with a need to know.

12. Estimates of Hourly and Cost Burden

SBA Form 1222 – It is estimated to take 80 burden hours for the collection of this information according to a small survey of grant recipients. Approximately 64 Notice of Awards were sent out in Fiscal Year 2011 by the SBDC Office (64 SBDCs must submit an annual report and semi-annual report). The WBC Office issues approximately 110 Notice of Awards (which requires

quarterly reporting). The Office of Grants Management (OGM) issues approximately 500 each year which requires 4 reports each year. The resulting total is 2580.

2568 responses x 80 hour = 205,440 burden hours

The hourly cost burden is calculated using an average of salaries of State/Program Directors and Assistant State/Program Directors. Each of these people contributes to writing, gathering information, reviewing and proofreading the reports submitted which is approximately 40 hours each.

Average salary of State/Program Directors	\$85,000 (approx. \$40.86 per hour)
Average salary of Assistant State/Program Directors	\$70,000 (approx. \$33.65 per hour)
State/Program Directors - \$40.86 x 40 hours = \$1,634.40	

Assistant State/Program Directors - \$33.65 x 40 hours = \$1,346.00

Total – \$2980.40 x 2568 = **\$7,653,667.20 total cost burden for Form 1222**

B. SBA Form 1224 – This form is submitted once per year per the 64 SBDCs and once per year per the 113 WBCs. It takes approximately 20 minutes (or .33 hours) to fill the form out by the State/Program Director or Assistant State/Program Director.

Average of salaries - \$48.44 per hour

Burden hours - approximately 20 minutes (or .33 hours)

Total Burden hours - .33 hours x 177 responses per year = 58.41 hours

\$48.44 x .33 hours x 177 responses = **\$2,829.38 total cost burden for Form 1224**

Total for both forms – \$7,656,496.58

SBA Form 1222 - A Program Manager with an average salary of a GS-13, step 5 with an hourly rate of \$42.00 reviews and provides a summary of the reports submitted. Each review takes approximately 2 hours. \$42.00 x 2 hours x 2568 responses = \$215,712.00 annual cost to the Federal Government.

SBA Form 1224 - A Program Manager with an average salary of a GS-13, step 5 with an hourly rate of \$42.00 reviews this for completeness and accuracy which takes approximately 15 minutes or .25 hours. $42.00 \times .25$ hours x 177 responses = \$1,858.50 annual cost to the Federal Government.

Total = \$217,570.50 cost to the Federal Government
