These costs are comprised of the following: Creating, reviewing, implementing and maintaining the functionality of the website customer satisfaction survey, takes one staff 30 minutes at \$31 per half hour (\$62 per hour), 1 course per month, at 12 courses annually = \$372.

In addition, support staff review the completed surveys, at \$372 x 5 staff (at same rate and time frames) = \$1,860.
