**FEDERAL COST:** The estimated annual cost to the Federal government is approximately \$240 annually. These costs are comprised of the following: Creating, reviewing, implementing and maintaining the functionality of the iCare - CMET Post Course survey. The breakdown of costs are as follows:

- One employee spends 5 minutes, costing \$5 (based on \$60 per hour), to create, implement and maintain one survey per course. IHS offers approximately 8 courses annually x \$5 each = \$40.
- Five employees spend 5 minutes at \$5 each (based on \$60 per hour) to review survey responses. IHS offers approximately 8 courses annually, at \$40 x 5 staff = \$200

Total cost = \$240 annually
