# Application for Land for Recreation or Public Purposes (43 CFR 2740 and 2912)

#### **General Instructions**

#### **Specific Instructions**

#### **Justification**

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.

The Bureau of Land Management (BLM) uses the information collection to decide whether or not to lease or sell certain public lands to applicants under the Recreation and Public Purposes (R&PP) Act, 43 U.S.C. 869 to 869-4. The Act authorizes the Secretary of the Interior to lease or sell, for recreational or public purposes, certain public lands to State, Territory, county, and local governments; nonprofit corporations; and nonprofit associations. BLM regulations at 43 CFR Parts 2740 and 2912 provide standards and procedures for implementing the Act. The BLM collects no similar information from the same universe of respondents.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection. Be specific. If this collection is a form or a questionnaire, every question needs to be justified.

The BLM collects and uses the applicant's information once to determine if the applicant meets all requirements of the act and regulations to lease or purchase lands for recreational or public purposes.

The BLM uses the information on Form 2740-1 (Application for Land for Recreation or Public Purposes) as follows:

<u>Item #1a:</u> Applicant's name? The BLM uses the information to identify the applicant.

<u>Item #1b:</u> Applicant's address, home phone number, and business phone number? The BLM uses the information to identify and communicate with the applicant.

<u>Item #2:</u> Give legal description of the lands applied for: Subdivision; Section; Township; Range; and Meridian? The BLM uses the information to identify the location of the lands, and determine if the lands meet the requirements of the Act and regulations.

<u>Item #3a:</u> This application is for lease or purchase? The BLM uses information to determine the method of disposal. If the applicant plans to lease the lands, the BLM uses the years to determine the expiration date of the lease.

<u>Item #3b:</u> Proposed use is public recreation or other public purposes? The BLM uses the information to determine what the applicant pays for the lands.

<u>Item #4:</u> Describe the proposed use of the land. The description must specifically identify an established or definitely proposed project. Attach a detailed plan and schedule for development, a management plan which includes a description of how any revenues will be used, and any known environmental or cultural concerns specific to the land? The BLM uses the applicant's construction schedule, development and management plans, and estimated revenue expenditures to determine if the applicant's proposed project is well planned, adequate, effective, realistic, and practical. If the proposed project substantially interferes with the environment or cultural resources, the applicant must select another site for the project.

<u>Item #5:</u> If the applicant is State or Political subdivision thereof, cite your statutory or other authority to hold land for these purposes? The BLM uses the information to determine the applicant's qualifications (governmental or nonprofit entity), if the applicant is registered to do business in the State, if the applicant has the authority to hold or acquire the lands, and if the signing official has the authority to act on the applicant's behalf.

<u>Item #6:</u> Attach a copy of your authority for filing this application and to perform all acts incident thereto? The BLM uses the information to verify the applicant's qualifications (governmental or nonprofit entity), if the applicant is registered to do business in the State, if the applicant has the authority to hold or acquire the lands, and if the signing official has the authority to act on the applicant's behalf.

<u>Item #7:</u> If the land described in this application has not been classified for recreation and/or public purposes pursuant to the Act, consider this application as a petition for such classification? The BLM uses this statement to eliminate the petition for classification form from the collection.

<u>Item #8:</u> Are all activities, facilities, services, financial aid, or other benefits as a result of your proposed development provided without regard to race, color, religion, national origin, sex, or age? To lease or purchase lands under the Act the applicants must obligate themselves to the following commitment: Nondiscrimination as to access to the lands and facilities based on race, color, religion, sex, age, or national origin in accordance with Title VI of the Civil Rights Act of 1964 (78 Stat. 241).

<u>Item #9:</u> Are all activities, facilities, and services constructed or provided as a result of your proposed development accessible to and usable by persons with disabilities? To lease or purchase lands under the Act applicants must obligate themselves to the Americans and Disabilities Act of 1990 (101 Stat. 327).

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden and specifically how this collection meets GPEA requirements.

Form 2740-1 is electronically available to the public in fillable, printable format on BLM's Forms Web site at <a href="http://www.blm.gov/noc/st/en/business/eForms.html">http://www.blm.gov/noc/st/en/business/eForms.html</a>. A respondent who chooses to submit the form electronically may do so by scanning and then emailing it to the appropriate BLM office. The requested information is unique to each respondent.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

The information collection is unique to the R&PP Act and regulations. The BLM is the only agency collecting this information. The BLM is unable to use or modify existing information collections to process new applications because the applicant's responses are distinct, unrelated, and specific to their individual proposed project.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

Respondents are State, Territory, county, and local governments; nonprofit corporations; and nonprofit associations. The BLM does not collect information about the size of the respondents. The BLM assumes that all of the private-sector respondents may be small businesses or other small entities.

There are no special methods used to minimize the burden because the information collected by the BLM is limited to the information required for an applicant to meet the requirements of the R&PP Act and the relevant regulations.

6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

The BLM is the only Federal agency responsible for implementing the R&PP Act. Failure to collect the information, or reducing the burden would preclude the collection of sufficient information to determine if the applicant meets the statutory requirements of the R&PP Act and regulations.

- 7. Explain any special circumstances that would cause an information collection to be conducted in a manner:
  - requiring respondents to report information to the agency more often than quarterly;
  - \* requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
  - \* requiring respondents to submit more than an original and two copies of any document;
  - \* requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records, for more than three years;

There are no special circumstances that require the collection to be conducted in a manner inconsistent with the guidelines. We do not exceed the guidelines in 5 CFR 1320.5.

#### **Public Comments**

Two Comments from One Commenter

On June 13, 2012, the BLM published the required 60-day notice in the Federal Register (77 FR 35421), and the comment period ended August 13, 2012. The BLM received three comments, two of which were from the same commenter and were sent by electronic mail on June 13, 2012.

The first comment requested the yearly report from 2011 that details what land was sold or leased, where it was located, how much it sold for, and the acreage. The commenter stated that the information was necessary in order to prepare a comment, and asked for an extension of time to prepare a comment "for the public record." On June 13, 2012, the BLM responded to this comment by sending to the commenter an electronic mail that contained a link to the following Web site: <a href="http://www.blm.gov/public\_land\_statistics/index.htm">http://www.blm.gov/public\_land\_statistics/index.htm</a>.

This Web site contains links to the 1996 to 2011 issues of *Public Land Statistics*, a BLM publication that summarizes the BLM's accomplishments and activities annually. For example, Table 3-1 of the 2011 issue of *Public Land Statistics* (at page 68) shows that the BLM granted 26 land patents under the R&PP Act in 2011. These patents were for lands totaling 2,837 acres, and yielded \$32,374 in Federal revenues.

In the second comment, the commenter expressed opinions on matters such as the data in *Public Land Statistics*, horse roundups, and grazing. The commenter also stated in this second comment that "this is my comment for the public record." In view of this statement, the BLM assumes that no response was necessary to address the commenter's previous request for an extension of time to prepare a comment.

#### A Third Comment

The third comment was faxed to the BLM on June 16, 2012 by a different commenter. It included a partial copy of the 60-day notice, and asked the BLM to put the commenter on our "email notification list for this." The commenter also asked, "Do you have more information than what is in this notice?" The BLM responded with an email message. The message:

- Informed the commenter that the BLM does not maintain an "email notification list" for this matter:
- Included instructions for obtaining data and documents regarding the BLM's 2009 request for renewal at <a href="http://www.reginfo.gov/public/do/PRAMain">http://www.reginfo.gov/public/do/PRAMain</a>; and
- Informed the commenter that there will be an additional opportunity to submit comments on the current request to the OMB in the near future, when the BLM publishes the 30-day notice.

The BLM attached a copy of Form 2740-1 to its response, and called attention to this attachment in its electronic message.

None of the comments addressed the information collection. Therefore, the BLM has not changed the collection in response to any of these comments.

#### **Public Consultation**

The BLM has consulted with the following respondents to obtain their views on the availability of data; frequency of collection; the clarity of instructions; the recordkeeping, disclosure, and reporting formats; and on the data elements to be recorded, disclosed, or reported:

The respondents had no issues regarding the application form, including clarity of instructions, availability of data, and elements being collected. However they did have concerns about the BLM's processing times and changing staff during processing of the case. This concern did not relate to the form content. Respondents provided the burden estimates shown under in Question 12 of this supporting statement.

9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

The applicant receives no payments or gifts.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

The BLM provides the respondents no assurance of confidentiality.

Table 12-3, below, shows our estimates of the annual hour and hour-related cost burdens. The estimated hourly wage was calculated as shown in Tables 12-1 and 12-2. Based on informal discussions with the respondents listed under Question 8, we estimate it will take respondents approximately 920 burden hours to complete the R&PP Application Form.

Pursuant to 43 CFR 2742.4, all applications must be accompanied by a one-time non-refundable filing fee of \$100. Based on the estimated number of applications filed annually, we estimate that respondents incur the following non-hour costs annually:

- \$2,100 for States, Territories, county, and local governments;
- \$100 for nonprofit associations; and
- \$100 for nonprofit corporations.
