**Declaration of Persons Who Performed Repairs or Alterations**

**Justification**

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

The "Declaration of Persons Who Performed Repairs or Alterations," as required by 19 CFR 10.8, is used in connection with the entry of articles entered under subheadings 9802.00.40 and 9802.00.50, Harmonized Tariff Schedule of the United States (HTSUS). Articles entered under these HTSUS provisions are articles that were in the U.S. and were exported temporarily for repairs. Upon their return, duty is only assessed on the value of the repairs performed abroad and not on the full value of the article. The declaration under 19 CFR 10.8 includes information such as a description of the article and the repairs, the value of the article and the repairs, and a declaration by the owner, importer, consignee, or agent having knowledge of the pertinent facts. The information in this declaration is used by CBP to determine the value of the repairs and assess duty only on the value of those repairs.

This information is submitted by members of the trade community who are familiar with CBP regulations.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The information in the declaration is used by CBP to determine the value of the repair and assess duty only on the value of that repair. Without this information, importers would have to pay duty on the full value of the imported article.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. CBP does not have the funds to automate this collection of information.

This information is not duplicated in any other place or any other form.

Public comments were solicited through two Federal Register notices published on February 23, 2012 (Volume 77, Pages 10762) and on May 7, 2012 (Volume 77, Pages 26776). As of this submission, no comments have been received.

There is no offer of a monetary or material value for this information collection.

**Public Cost**

The estimated cost to the respondents is \$204,720. This is based on the estimated burden hours (10,236) multiplied (x) hourly rate (\$20.00).

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

The annual estimated cost to the Federal Government associated with reviewing and processing the information is \$142,716. This is based on the time spent per response (10 minutes or .166 hours) x number of responses (20,472) = 3,398 hours expended x an annual rate of \$42.00 = \$142,716.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There are no changes to the information collected.
