

**Supporting Statement**  
**Application for Extension of Bond for Temporary Importation**

**Justification**

Imported merchandise which is to remain in the customs territory for a period of one year or less without the payment of duties is entered as a temporary importation, as authorized under the Harmonized Tariff Schedules of the United States (19 U.S.C. 1202). When this time period is not sufficient, it may be extended by submitting an application on CBP Form 3173, "*Application for Extension of Bond for Temporary Importation*". The data collected on CBP Form 3173 will be used by the port director to determine the necessity for granting an extension of the temporary importation period.

98 percent of this information is transmitted electronically through the Automated Broker Interface (ABI), which is a non web-based automated system that is a module of CBP Automated Commercial System (ACS).

This information is not duplicated in any other place or any other form.

Public comments were solicited through two Federal Register notices published on February 7, 2012 (Volume 77, Page 6136) on which no comments were received and on April 10, 2012 (Volume 77, Page 21578) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

**Public Cost**

The estimated cost to the respondents is \$72,920. This is based on the estimated burden hours (3,646) multiplied (x) the average hourly rate (\$20.00).

**13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information.**

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

**14. Provide estimates of annualized cost to the Federal Government. The estimated annual cost to the Federal Government associated with the review of these records is **\$117,138**. This is based on the number of responses (16,800) that must be reviewed (x) the time to review and process each response (.166 hours) = 2,789 hours (x) the average hourly rate (\$42.00) = \$117,138.

**15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13.**

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection and no changes to the information collected.

This information collection will not be published for statistical purposes.
