A. INCLUDE

1. Wholesale sales made by retail establishments covered by this report
2. Receipts from layaway purchases
3. Receipts from the rental or leasing of vehicles, equipment, instruments, tools, etc.
4. Receipts from deliveries
5. Receipts from installations, maintenance, repairs, alterations, storage, and other such services
6. Value of trade-ins taken as part payment for other merchandise
7. Excise taxes (such as those on gasoline, liquor, and tobacco) which are levied on the manufacturer or wholesaler and included in the cost of goods purchased by this firm

B. EXCLUDE

1. Commissions from vending machine operators
2. Non-operating receipts (such as interest income, income from investments, and receipts from rental or sale of real estate)
3. Commissions from sales of government lottery tickets

C. DEDUCT

1. Refunds and allowances for returned goods
2. The actual value of rebates and discounts granted to the purchaser, even if granted as an increase in trade-in allowance

D. DEFINITION

E-Commerce Sales are sales of goods and services where an order is placed by the buyer or price and terms of the sale are negotiated over an Internet, extranet, EDI, electronic mail, or other online system. Payment may or may not be made online.
