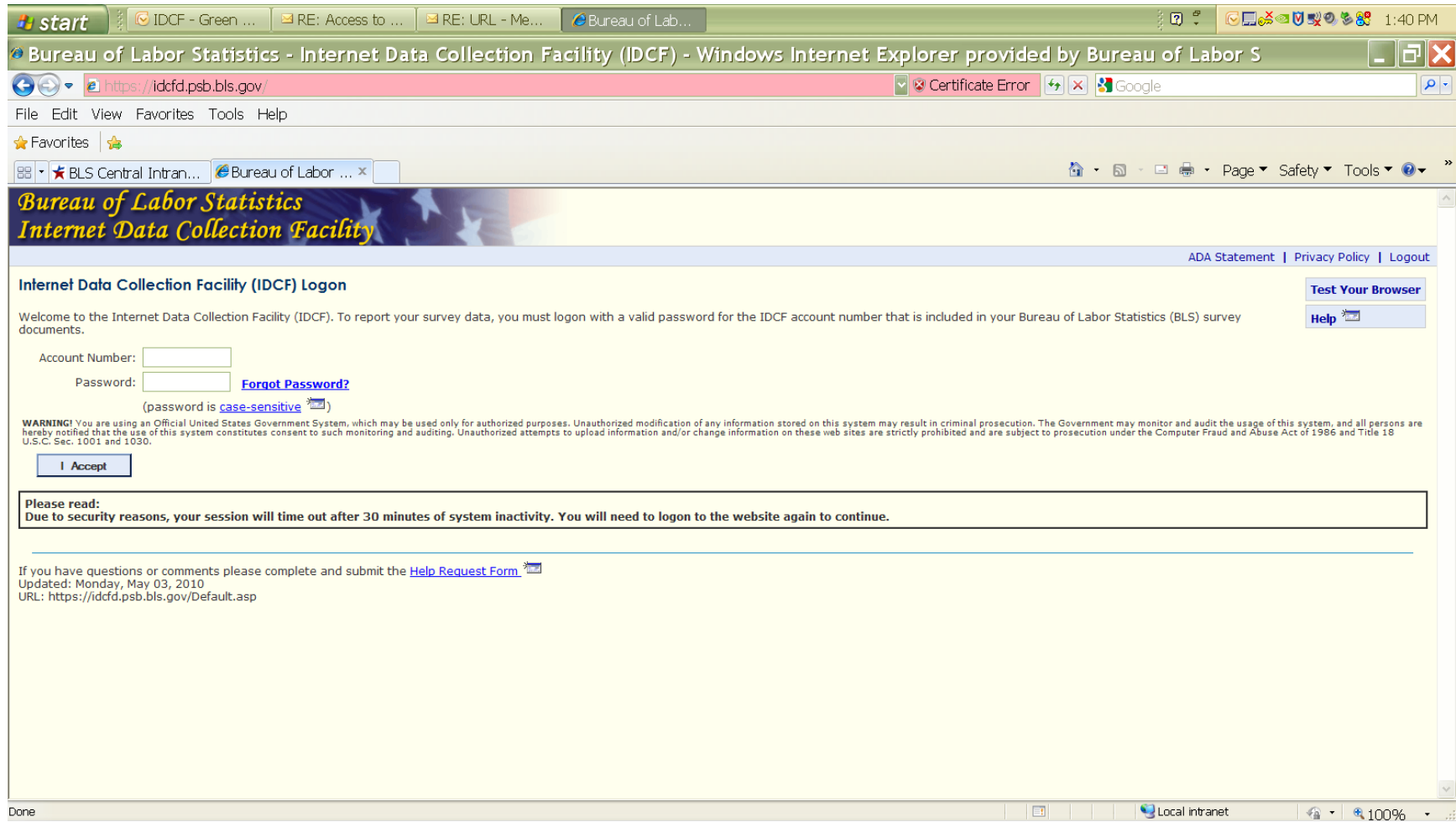

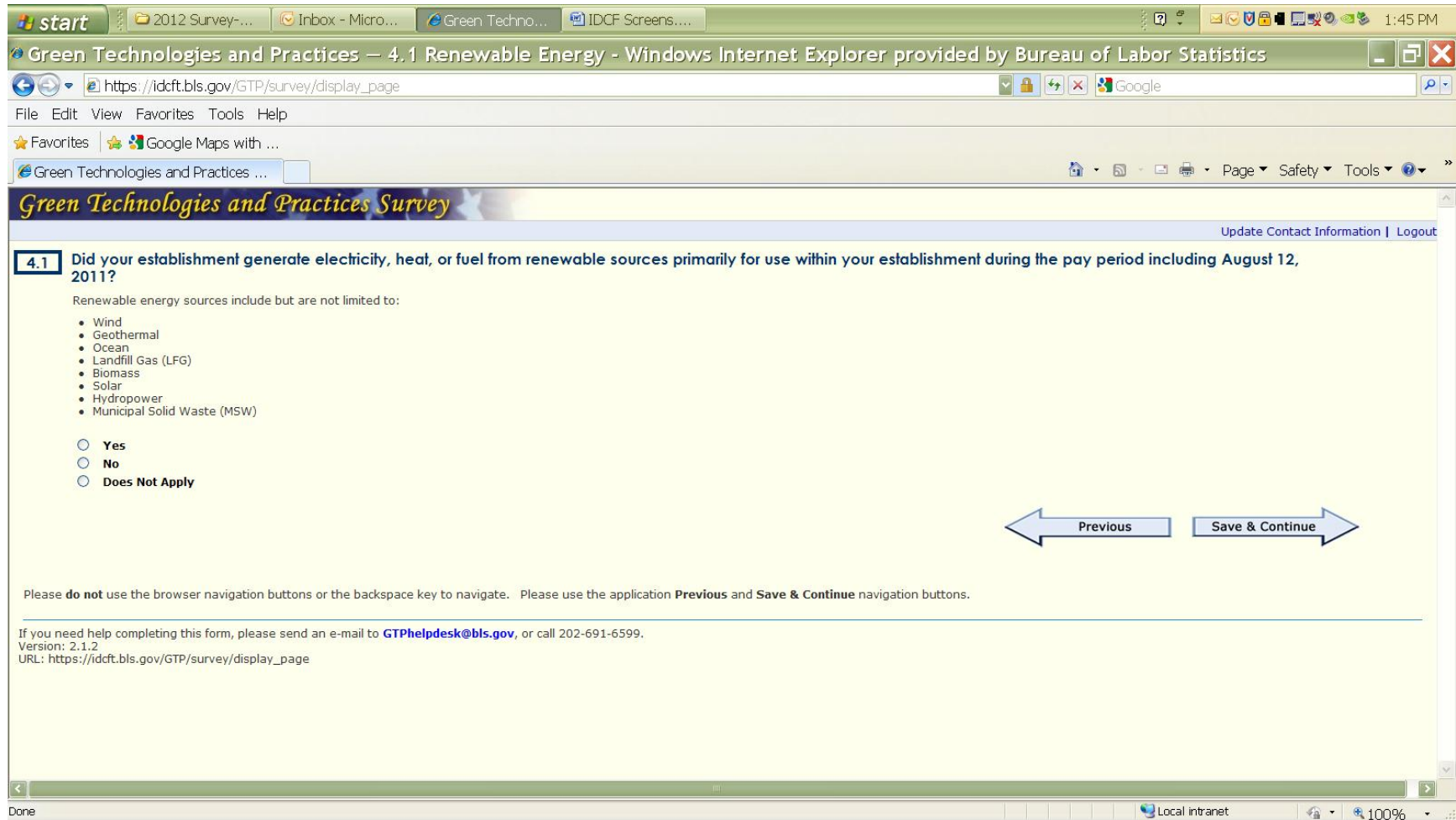

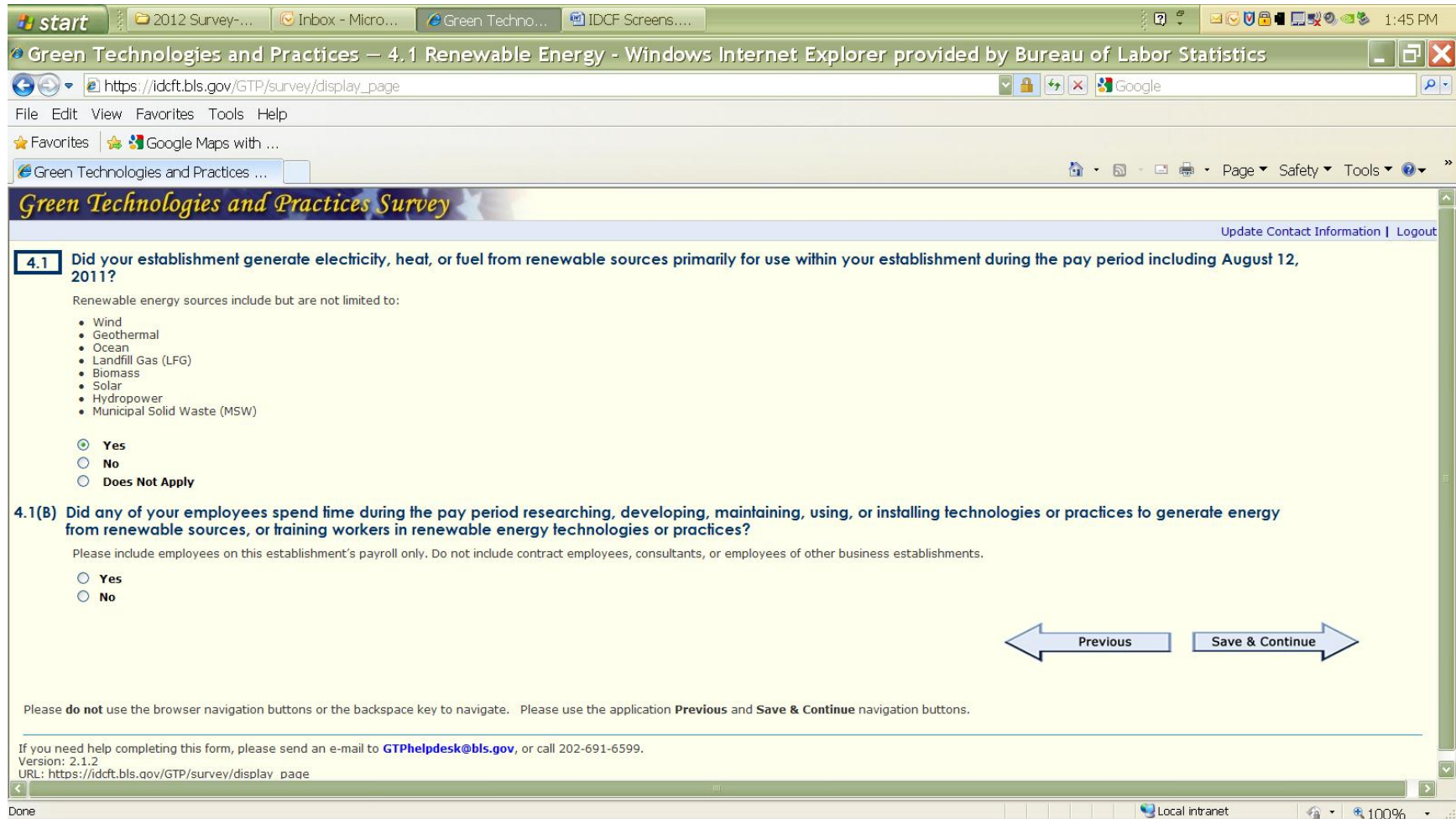
GTP Question 3 Screen – Economic activity



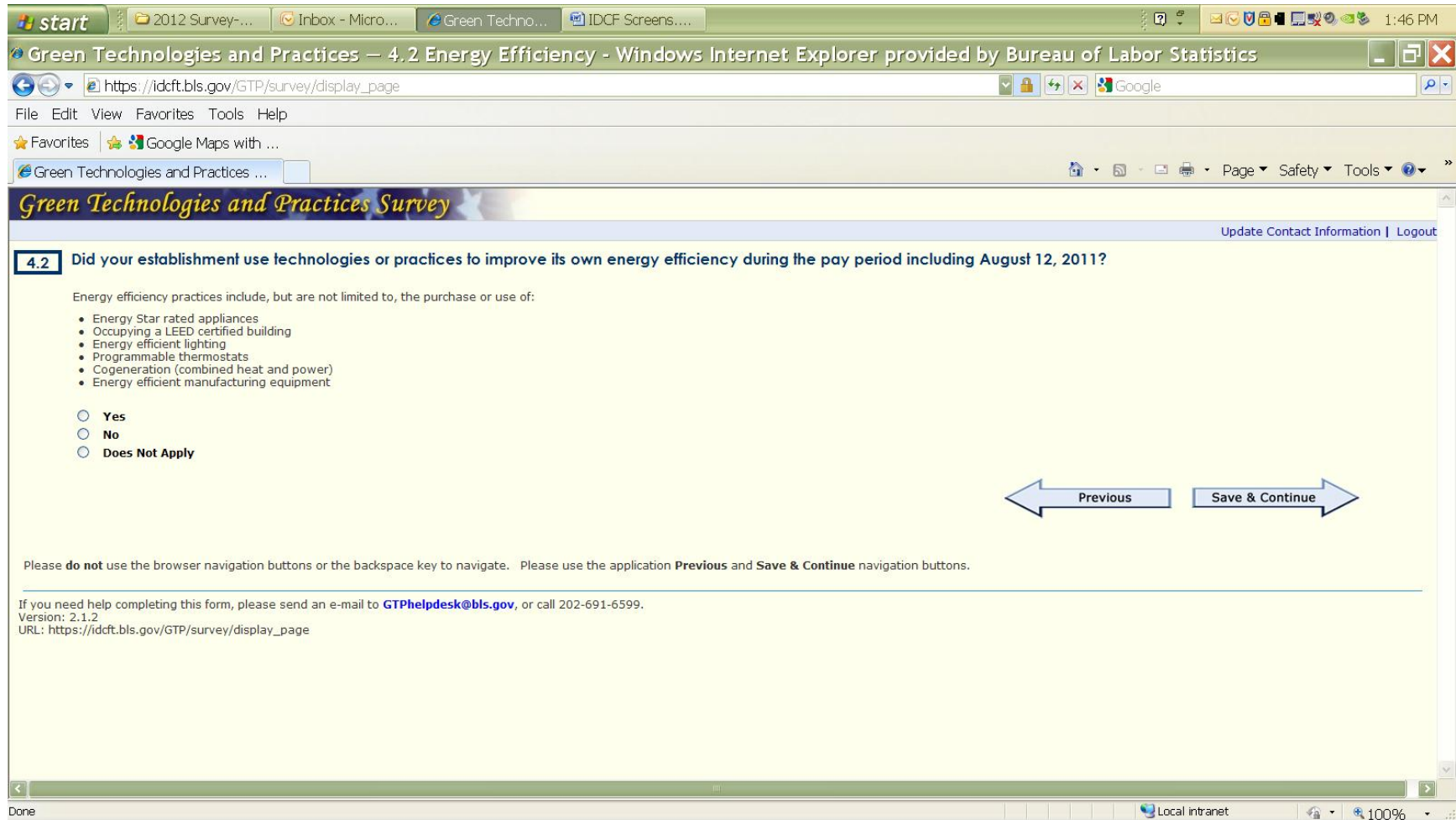
GTP Question 4.1 Screen – Renewable Energy



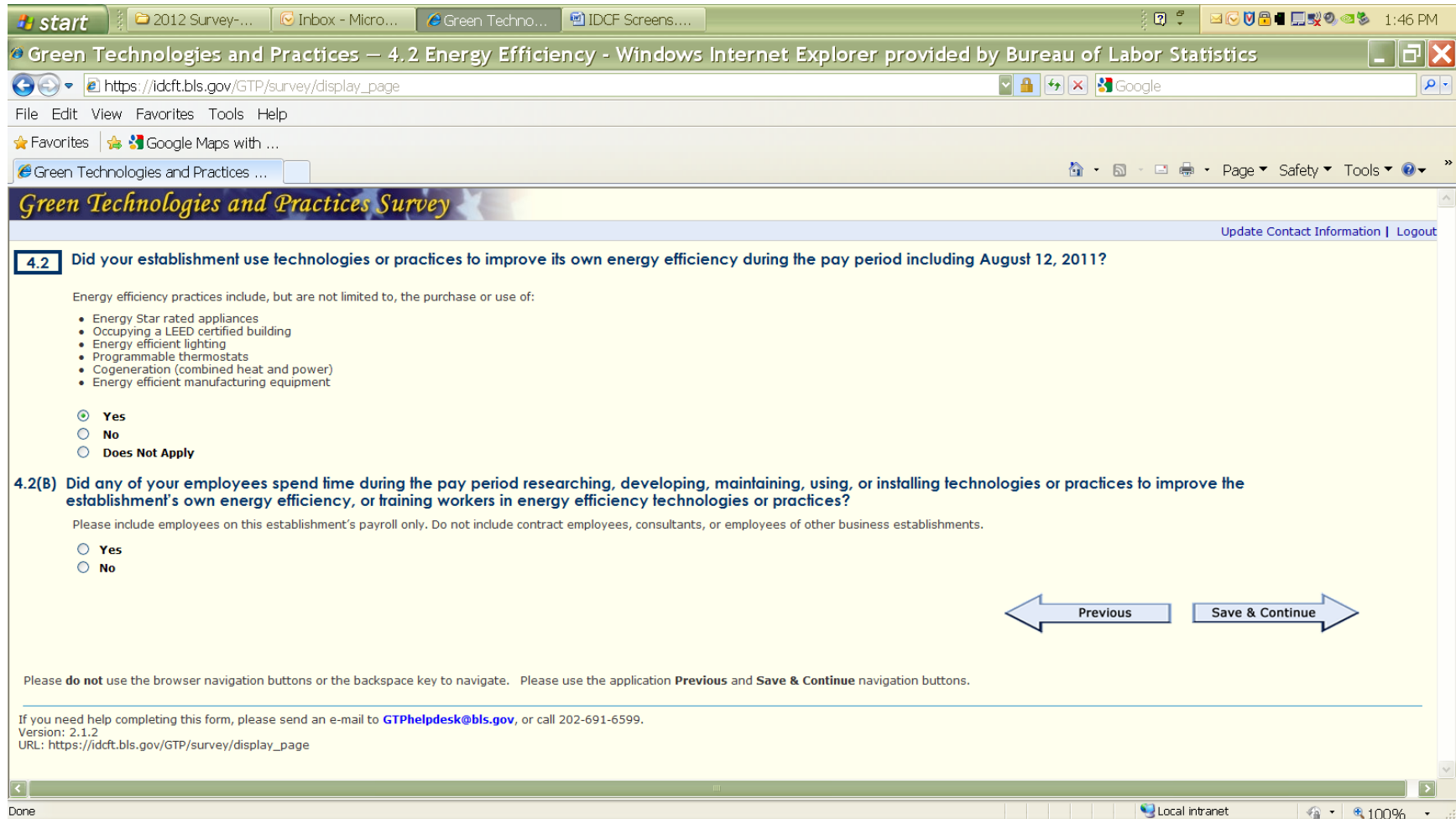
GTP Question 4.1.B Screen – Renewable Energy Employees



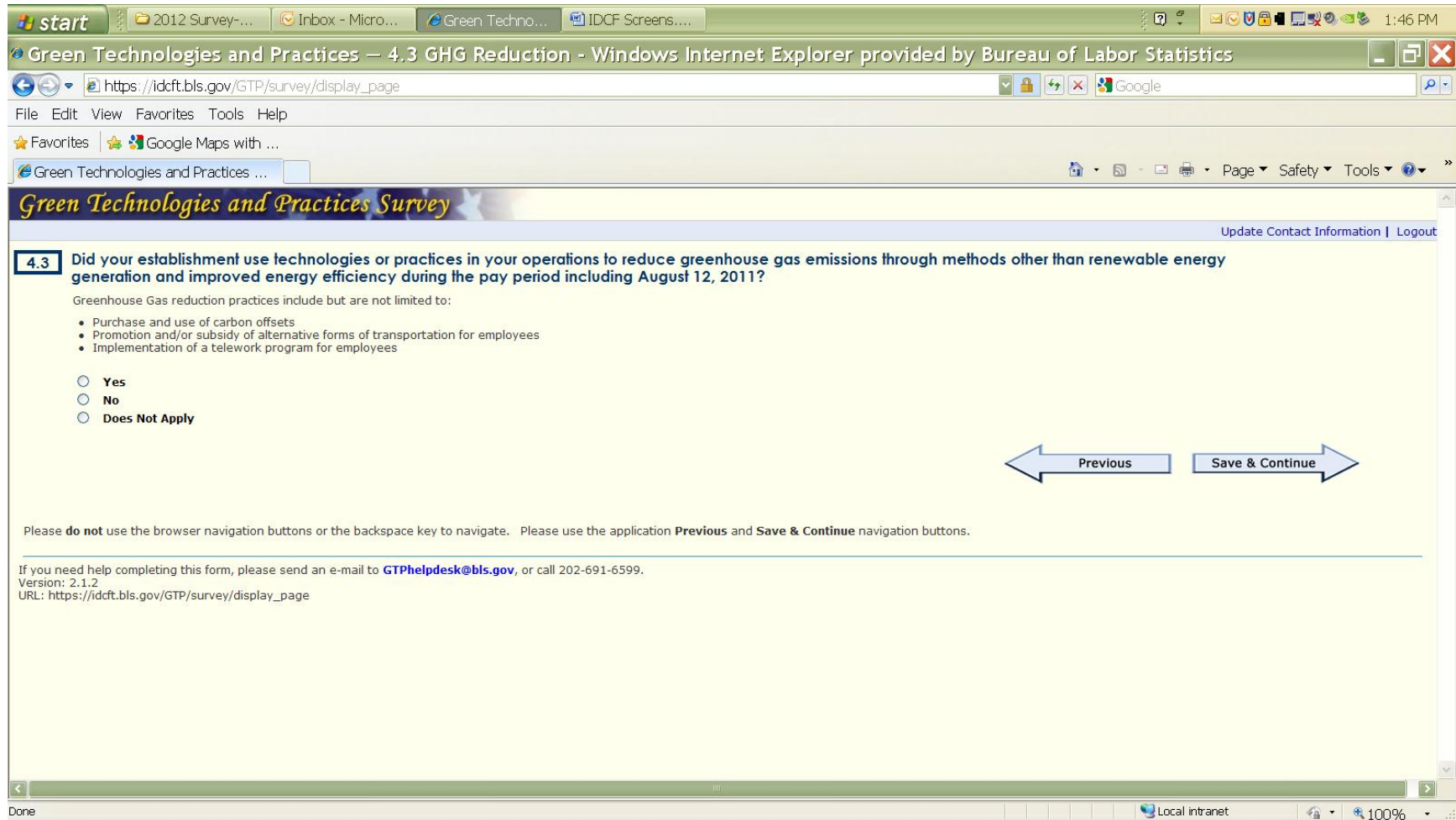

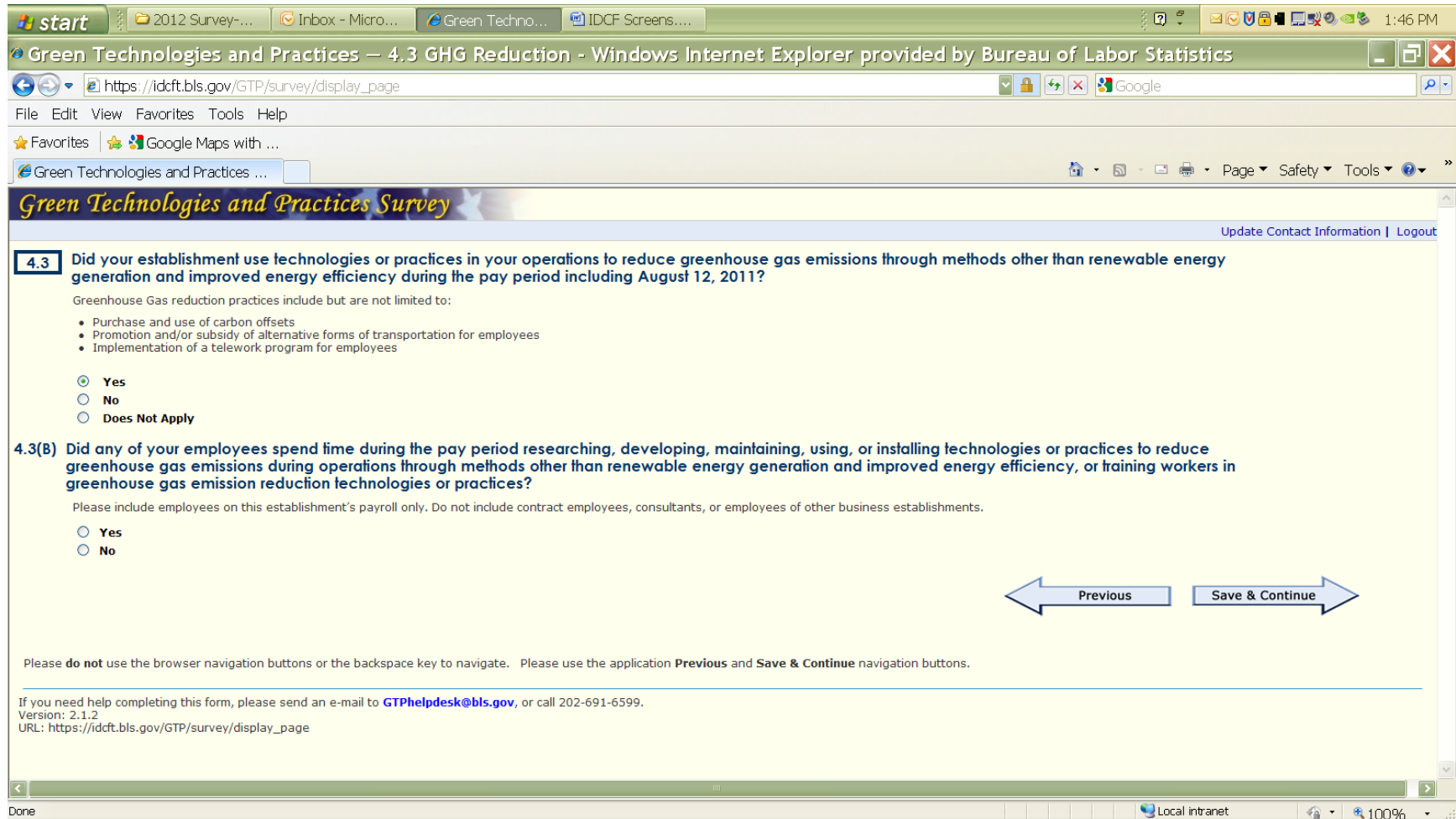

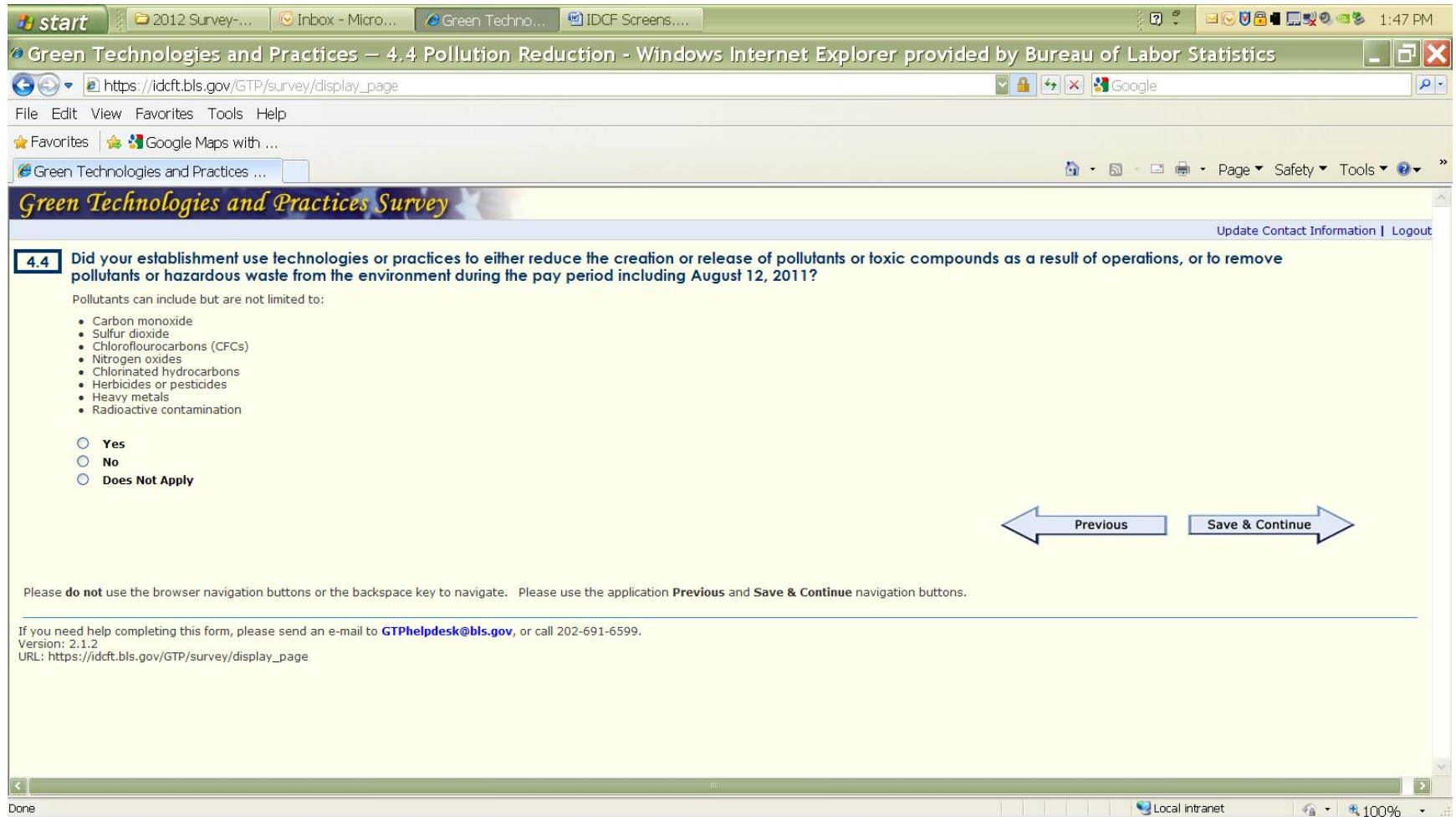

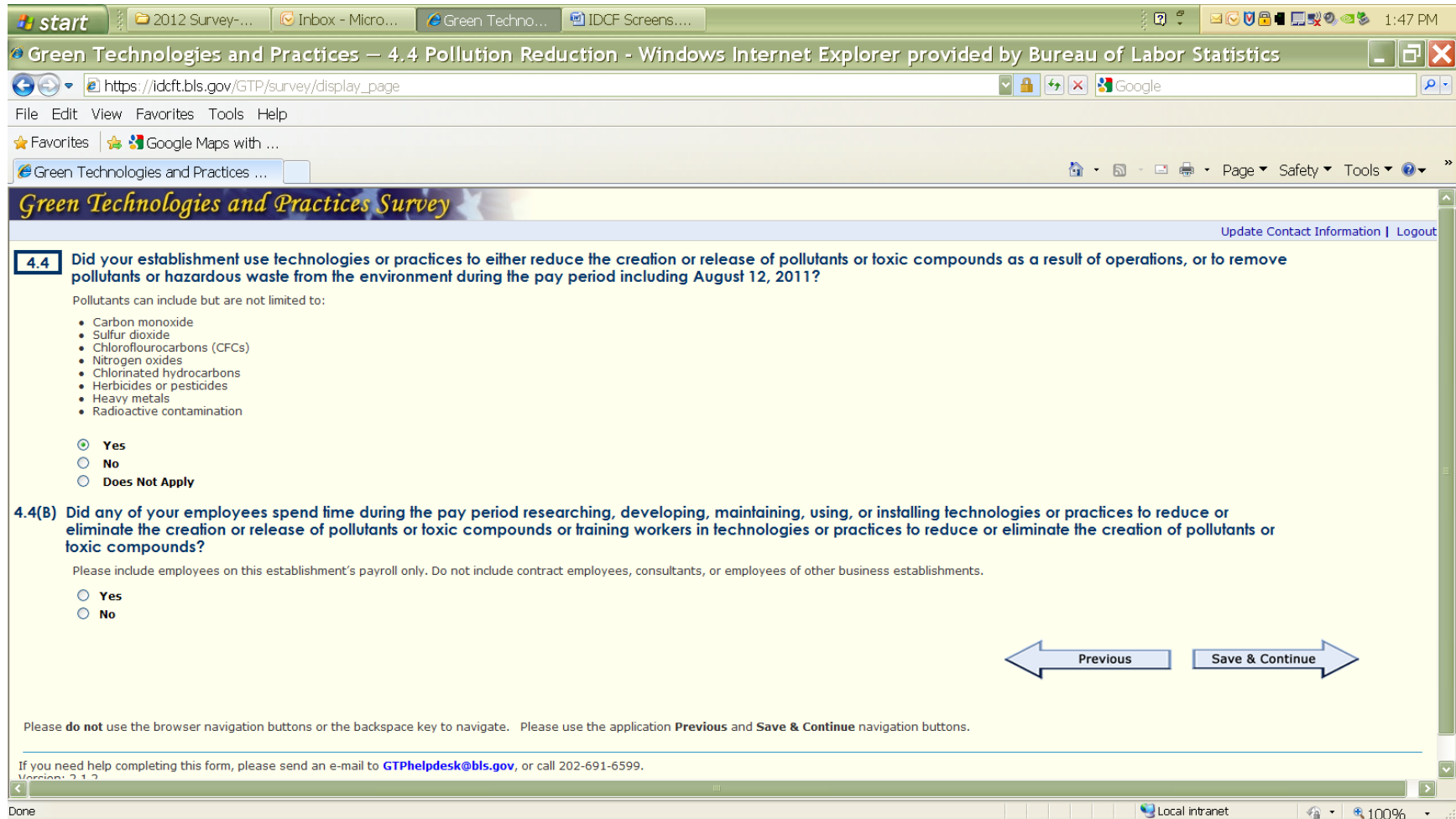




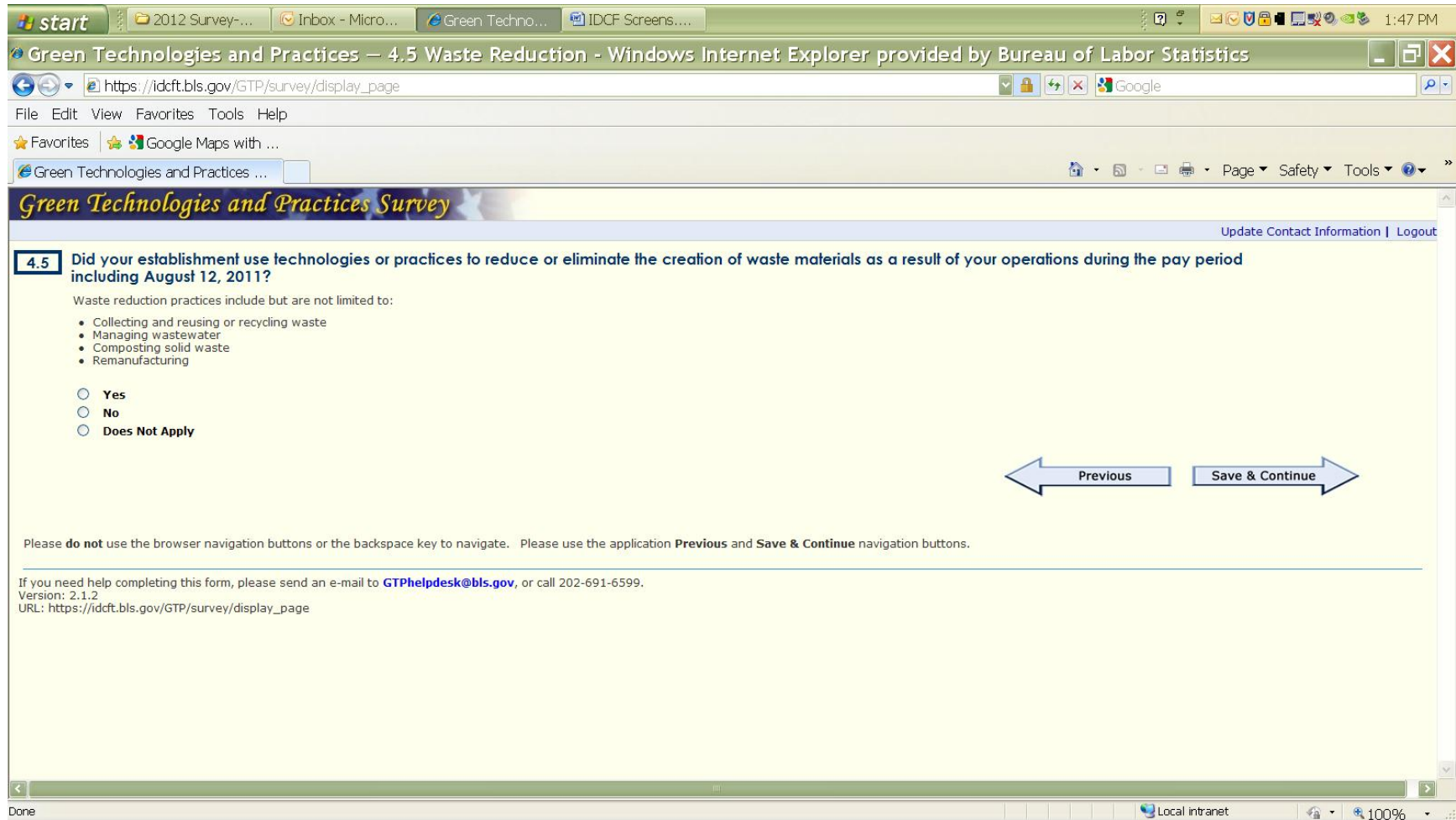

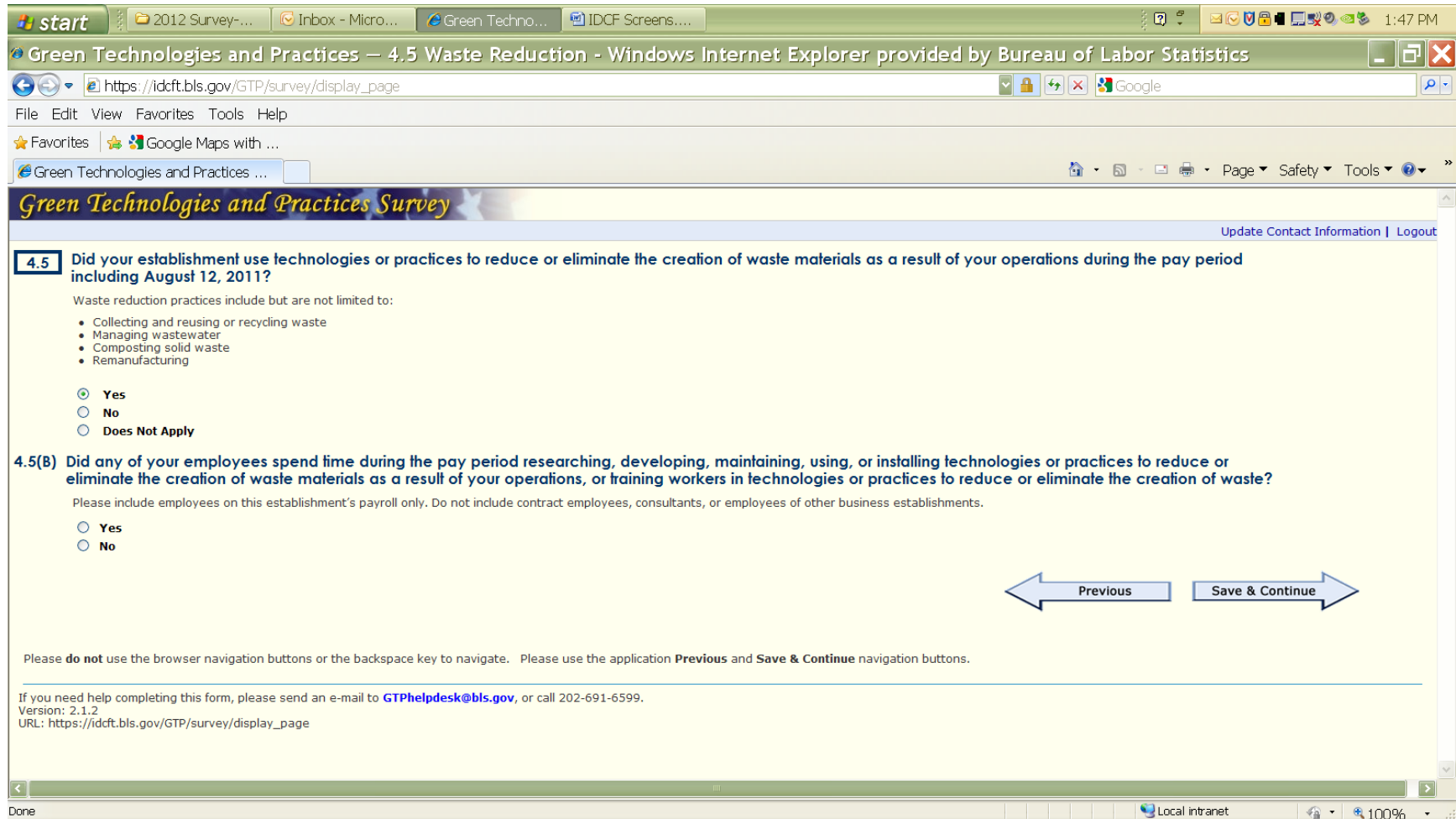

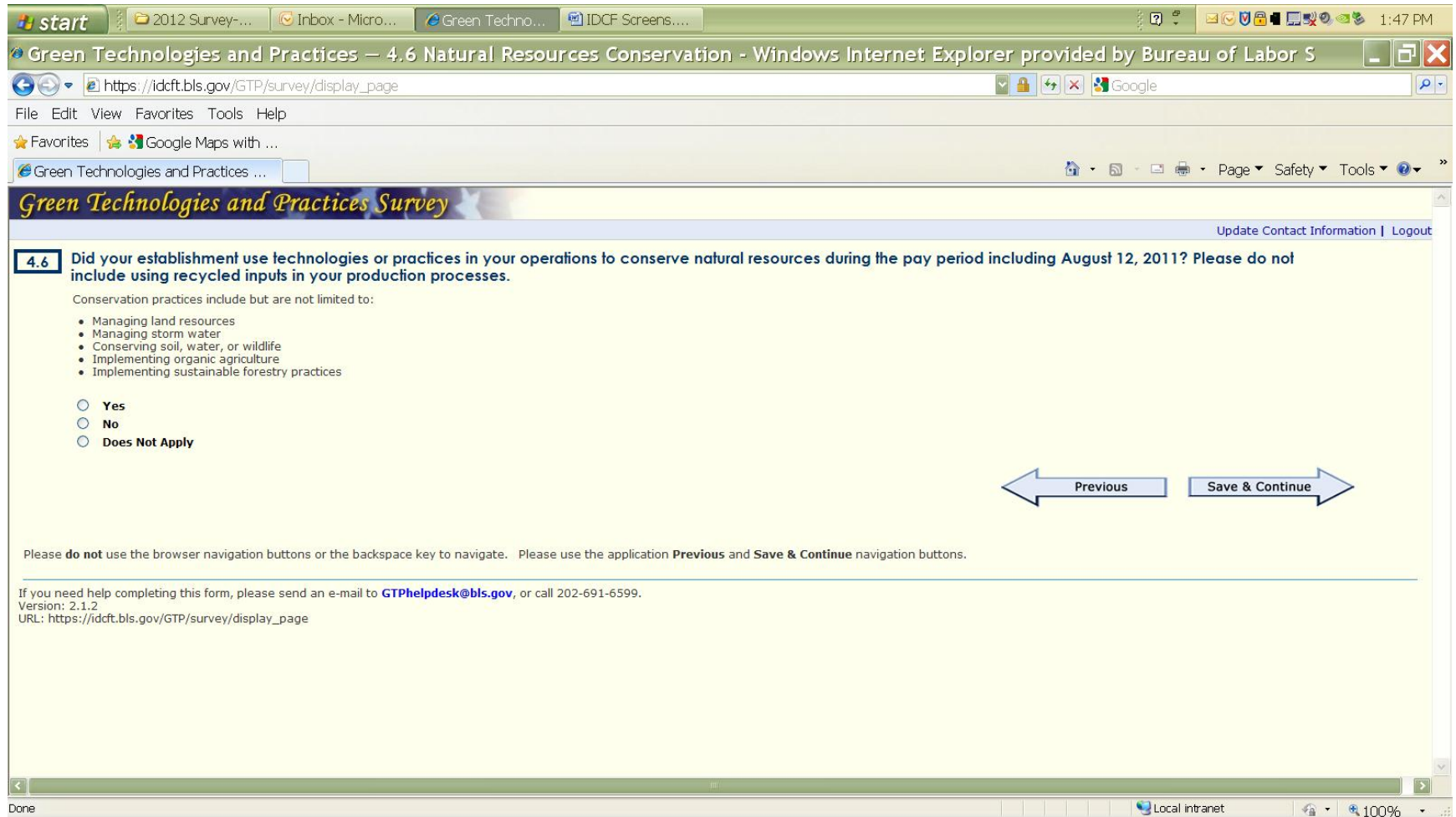

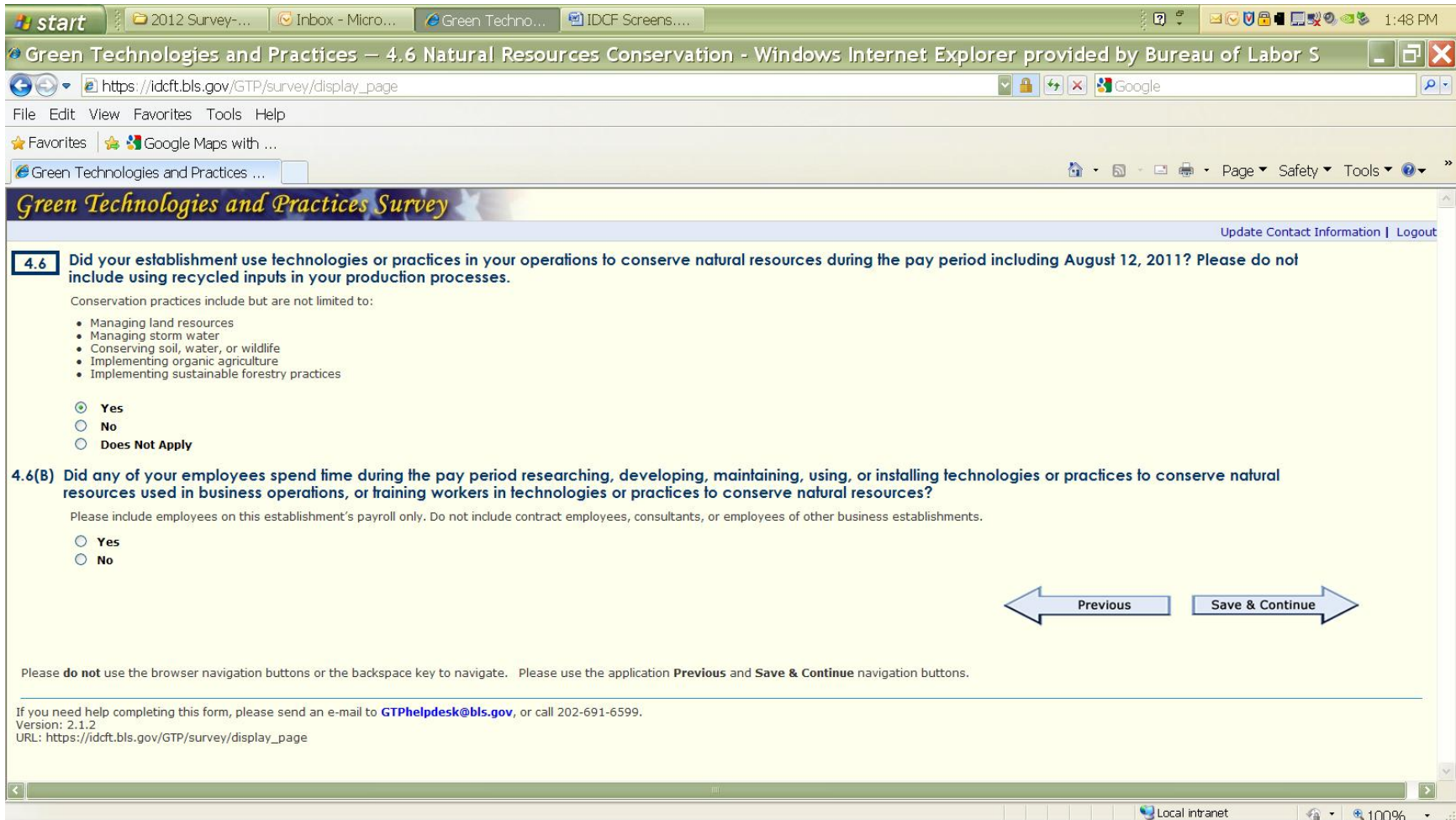

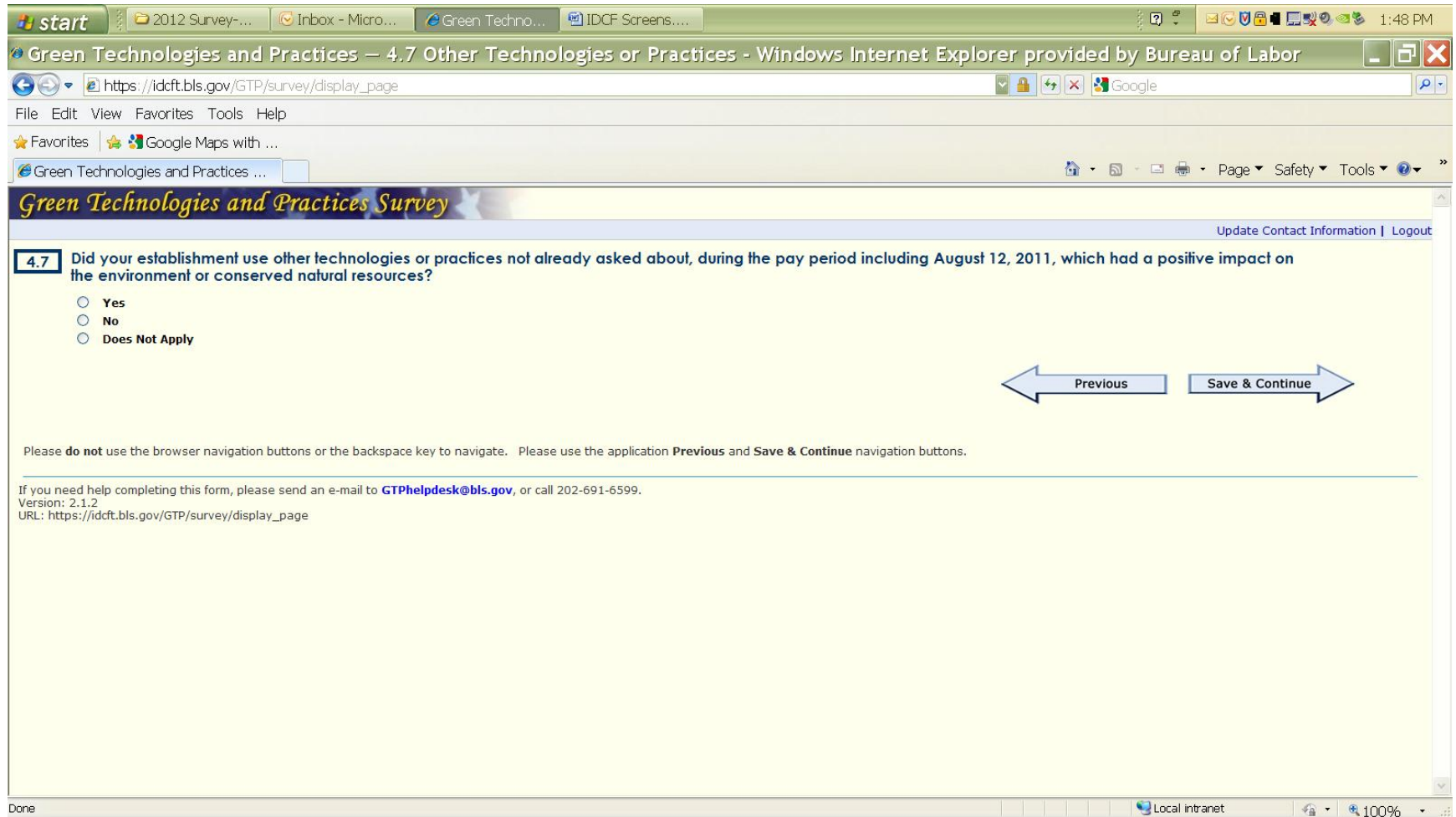

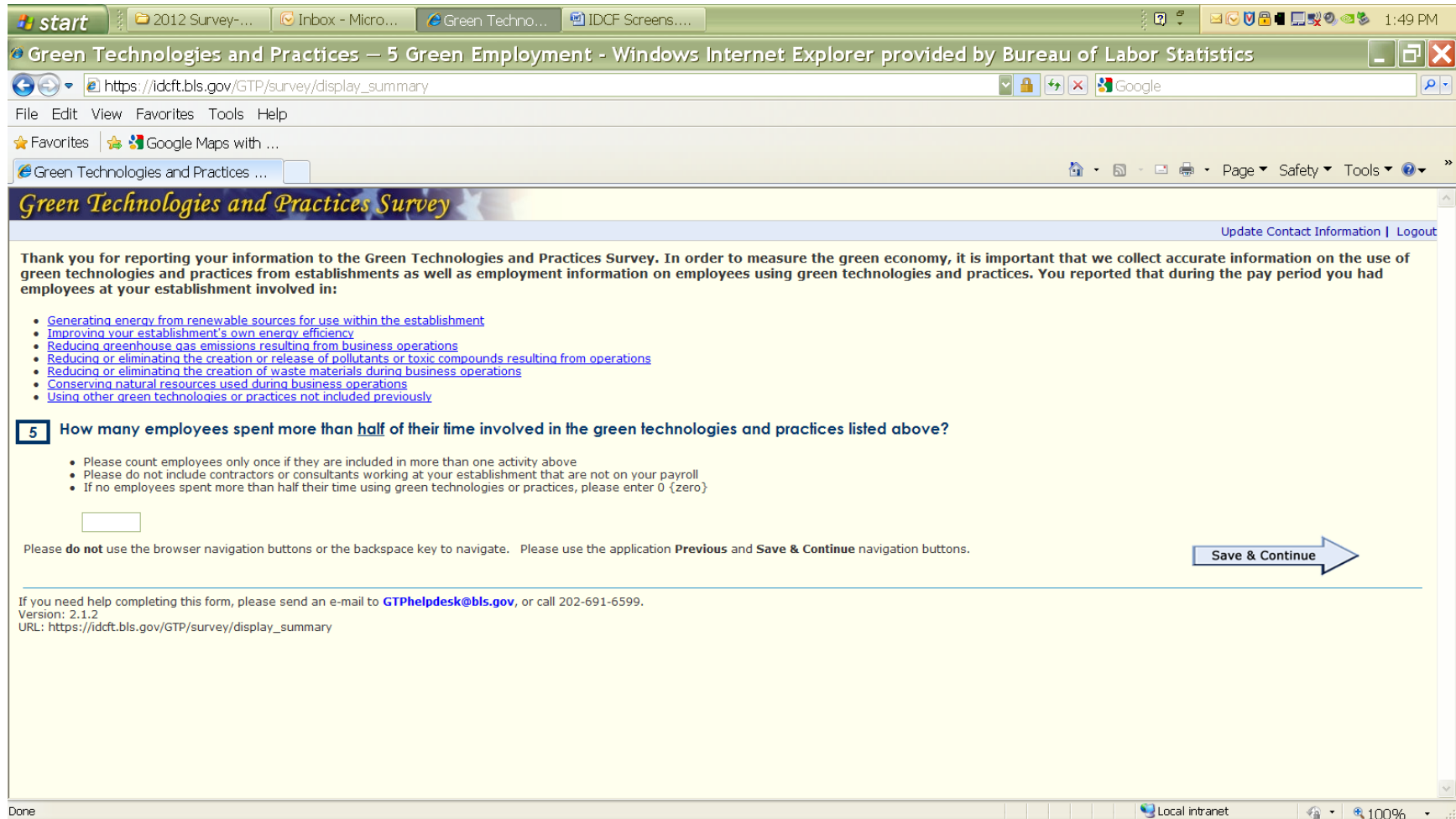

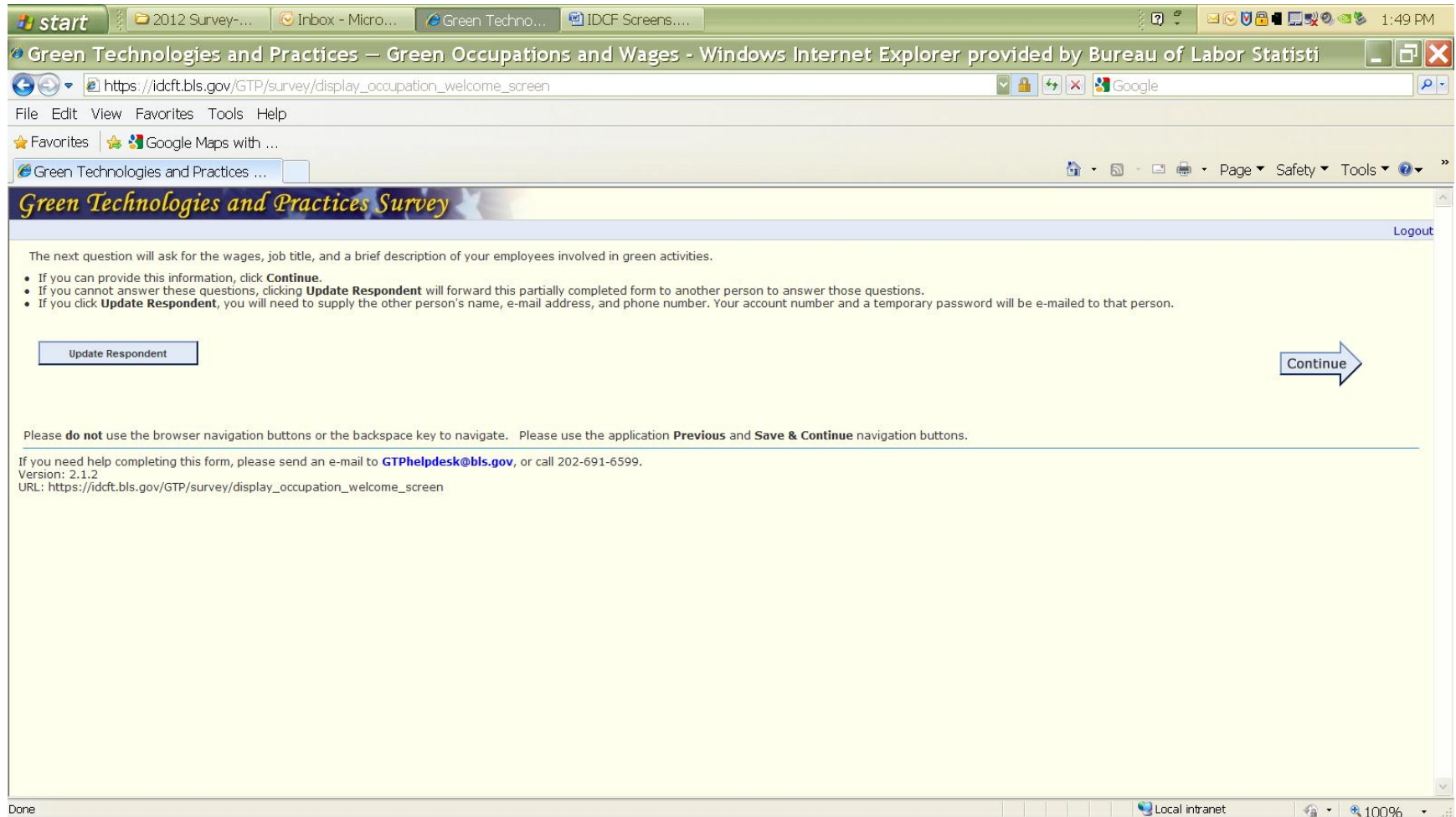


GTP Question 5 Screen –Summary of green activities reported with associated employment, and green employees
