## **GENERAL INFORMATION**

**Background**.-- On June 15, 1987, the Department of Commerce issued an antidumping duty order on imports of tapered roller bearings ("TRBs") from China (52 F.R. 22667). On August 1, 2012, the Commission instituted a review pursuant to section 751(c) of the Tariff Act of 1930 (19 U.S.C. § 1675(c)) (the Act) to determine whether revocation of the order would be likely to lead to continuation or recurrence of material injury to the domestic industry within a reasonably foreseeable time (76 F.R. 45853). If the Commission makes an affirmative determination, the order will remain in place. If the Commission makes a negative determination, the Department of Commerce will revoke the order.

**Due date of questionnaire(s)**.--Please submit the completed questionnaire(s) to the United States International Trade Commission so as to be received by no later than May 1, 2012. Because Commission staff might contact you with questions during the course of the proceeding, save the final version of the document(s) and retain all files and worksheets associated with the completed questionnaire(s). Please also retain a copy of any paper original document that you submit.

<u>Service of questionnaire response(s)</u>.--In the event that your firm is a party to this review, you are required to serve a copy of the questionnaire(s), once completed, on parties to the proceeding that are subject to administrative protective order (see 19 CFR § 207.7). A list of such parties is maintained by the Commission's Secretary and may be obtained by calling 202-205-1803. A certificate of service must accompany the copy of the completed questionnaire(s) you submit (see 19 CFR § 207.7).

<u>Confidentiality</u>.--The commercial and financial data furnished in response to the enclosed questionnaire(s) that reveal the individual operations of your firm will be treated as confidential by the Commission to the extent that such data are not otherwise available to the public and will not be disclosed except as may be required by law (see 19 U.S.C. § 1677f). Such confidential information will not be published in a manner that will reveal the individual operations of your firm; however, nonnumerical characterizations of numerical business proprietary information (such as discussion of trends) will be treated as confidential business information only at the request of the submitter for good cause shown.

<u>Verification</u>.--The information submitted in the enclosed questionnaire(s) is subject to audit and verification by the Commission. To facilitate possible verification of data, please keep all your workpapers and supporting documents used in the preparation of the questionnaire response(s).

<u>Release of information</u>.--The information provided by your firm in response to the questionnaire(s), as well as any other business proprietary information submitted by your firm to the Commission in connection with the review, may become subject to, and released under, the administrative protective order provisions of the Tariff Act of 1930 (19 U.S.C. § 1677f) and section 207.7 of the Commission's Rules of Practice and Procedure (19 CFR § 207.7). This means that certain lawyers and other authorized individuals may temporarily be given access to the information for use in connection with this review or other import-injury proceedings or reviews conducted by the Commission on the same or similar merchandise; those individuals would be subject to severe penalties if the information were divulged to unauthorized individuals.

<u>Answer all questions</u>.--Do not leave any question or section blank unless a questionnaire expressly directs you to skip over certain questions or sections. If the answer to any question is "none," write "none." **If information is not readily available from your records in exactly the form requested, furnish carefully prepared estimates.** Answers to questions and any necessary comments or explanations should be supplied in the space provided or on separate sheets attached to the appropriate page of the questionnaire(s). If your firm is completing more than one questionnaire in connection with this review (i.e., a producer, importer, purchaser, and/or foreign producer questionnaire), than you need not respond to duplicated questions in the questionnaires. Questionnaires may be filed either electronically or in paper form.

<u>Consolidate all establishments in China</u>.--Report the requested data for your establishment(s) located in China. Firms operating more than one establishment should combine the data for all establishments into a single report.

*Electronic completion*.--Your firm is encouraged (but not required) to complete the questionnaire electronically in MS Word format. The MS Word versions of all the questionnaires in this proceeding are available online at the ITC web page or may be obtained directly from the Commission's Investigator, Jennifer Merrill (jennifer.merrill@usitc.gov, or 202-205-3188).

*Electronic submission*.--To the degree that it is possible and not overly burdensome, the Commission requests that responding firms submit their questionnaire responses electronically in MS Word format. The submission of questionnaire responses in the MS Word format allows the Commission to compile, assess, and analyze submitted data more promptly. There are three electronic submissions options detailed below. Paper submissions are also accepted.

• <u>Upload via Secure Drop Box</u>.—Upload the completed questionnaire in MS Word format along with a scanned copy of the signed certification page (page 1) through the Commission's secure upload facility:

• **Compact disc (CD)**.—Copy your questionnaire onto a CD, include a signed certification page (page 1) (either in paper form or scanned PDF copied onto CD), and mail to the address above. *It is strongly recommended that you use an overnight mail service*. *U.S. mail sent to government offices undergoes additional processing which not only results in substantial delays in delivery but may also damage CDs*.

# **DEFINITIONS**

**Product**.-- Tapered roller bearings and parts thereof, finished and unfinished, including wheel hub assemblies, from the PRC; flange, take up cartridge, and hanger units incorporating tapered roller bearings; and tapered roller housings (except pillow blocks) incorporating tapered rollers, with or without spindles, whether or not for automotive use, as covered by statistical reporting numbers 8482.20.00, 8482.91.00, 8482.99.15, 8482.99.45, 8483.20.40, 8483.20.80, 8483.30.80, 8483.90.20, 8483.90.30, 8483.90.80, 8708.99.80.15,<sup>1</sup> and 8708.99.80.80<sup>2</sup> of the Harmonized Tariff Schedule of the United States (HTS).

<u>Wheel hub assemblies</u>.—For purposes of this review, a wheel hub assembly is a type of tapered roller bearing covered by this investigation that is finished and has one or more tapered rollers, an outer flange and, in many cases, and inner flange with a mounting face and studs onto which a vehicle wheel and a brake rotor or disc brake is mounted. A wheel hub assembly may be splined or non-splined and with or without ABS elements.

<u>*Firm*</u>.--An individual proprietorship, partnership, joint venture, association, corporation (including any subsidiary corporation), business trust, cooperative, trustee in bankruptcy, or receiver under decree of any court.

<u>**Related firm.</u></u>--A firm that your firm solely or jointly owned, managed, or otherwise controlled; a firm that solely or jointly owned, managed, or otherwise controlled your firm; and/or a firm that was solely or jointly owned, managed, or otherwise controlled by a firm that also solely or jointly owned, managed, or otherwise controlled by a firm that also solely or jointly owned, managed, or otherwise controlled your firm.</u>** 

*Establishment*.--Each facility of a firm in China involved in the production of TRBs (as defined above), including auxiliary facilities operated in conjunction with (whether or not physically separate from) such facilities.

<u>United States</u>.--For purposes of this review, the 50 States, Puerto Rico, the U.S. Virgin Islands, and the District of Columbia.

*Importer*.--Any person or firm engaged, either directly or through a parent company or subsidiary, in importing TRBs (as defined above) into the United States from a foreign manufacturer or through its selling agent.

Average production capacity.--The level of production that your establishment(s) could reasonably have expected to attain during the specified periods. Assume normal operating conditions (i.e., using equipment and machinery in place and ready to operate; normal operating levels (hours per week/weeks per year) and time for downtime, maintenance, repair, and cleanup; and a typical or representative product mix).

# **<u>DEFINITIONS</u>**--Continued

<u>**Production**</u>.--All production in your establishment(s) in China, including production consumed internally within your firm.

*Shipments*.--Shipments of products produced in your establishment(s) in China.

Shipment quantities.—Quantities reported should be net of returns.

<u>Shipment values</u>.—Values reported should be net values (i.e., gross sales values less all discounts, allowances, rebates, prepaid freight, and the value of returned goods) in <u>U.S.</u> <u>dollars</u>, f.o.b. your point of shipment in China.

*<u>Home market commercial shipments</u>.--Shipments, other than internal consumption and transfers to related firms, within China.* 

*Home market internal consumption/transfers to related firms*.--Shipments made to related firms in China, including product consumed internally by your firm.

*Export shipments*.--Shipments to destinations outside China, including shipments to related firms.

Inventories. -- Finished goods inventory, not raw materials or work-in-progress.
