What Happens Next

Once we receive your signed application, we will decide if you can get benefits. The sooner we receive it, the sooner we can decide.

We may use December 8, 2008 as the official date of this application. In order to use December 8, 2008, we must receive the **signed** application by June 15, 2009. You may **lose Social Security benefits** if we do not receive the signed application by June 15, 2009.
