**Instructions:**

1. Please answer all questions with reference to the forensic laboratory(s) specified on the label above. This census is directed to all Publicly Funded Forensic Crime Laboratories in the United States, defined as:
  1. a laboratory either funded solely by government or whose parent organization is a government agency; and
  2. one that employs one or more full-time scientists whose principal function is the examination of physical evidence for law enforcement agencies and that provides reports and testimony to courts of law with respect to such evidence.If you are unsure about your laboratory's eligibility, contact the Help Line (toll-free) at (877) 904-1621.
2. You are not required to complete the survey all at once. You may start, stop, and resume the survey as many times as you wish. Each time you navigate from one page to another, your responses will be saved. Once you submit your survey as complete, however, you will not be able to edit your responses.
3. Please complete the survey online by December 15, 2010.
4. Please do not leave any items blank. When you reach the "verification" section of the survey, you will be warned if your responses are incomplete and directed to the specific sections where you will be able to complete those items. If you submit an incomplete survey, the Census Team at the Urban Institute will contact you to clarify your responses.
5. If you require assistance with a particular question, you may put the cursor over or click the  next to the question to read the help text or you may mark the  help me with checkbox next to the question to signal the Census Team at the Urban Institute that you require assistance with that specific question. If you are unable to complete an item according to the directions, please call the Help Line. Definitions for key terms are provided. Place the cursor over or click the  next to the question to read the Information box or refer to the Help tab at the top of the screen for additional glossary items.
6. Based on some of your responses, you will be directed to skip certain questions. In the case that you do not have to answer a particular question, you will not be able to enter information into the response box and once you attempt to click in the response option, it will grey out and not allow you to respond. Please then move to the next item. There are cases where if you change the forensic functions of your laboratory, you will then need to check your responses to all questions pertaining to that discipline.
7. Once you have submitted your survey, please print (or save as a PDF) and retain a copy of the completed survey for your records.
