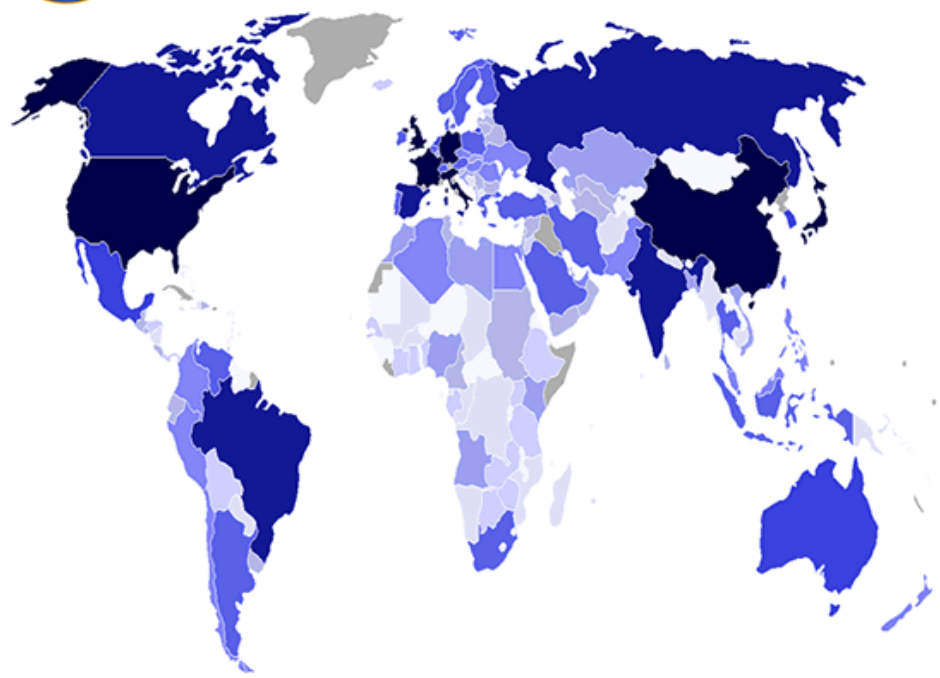
The Act establishes legal remedies permitting individuals to seek enforcement of their Privacy rights. In addition, Federal employees or contractors who fail to comply with the Acts provisions may be subject to criminal penalties.

About the Civilian Response Corps Database

Welcome to the Civilian Response Corps Database. This database is intended to collect information on Civilian Response Corps members, CSO staff, training students, and others for the purpose of quick deployment in a rapid response scenario.

This system stores personnel information, assists in the in- and out-processing of members, and can export your record to various forms. The system will also help you register for training. The database is also used to identify appropriate candidates for deployments and to facilitate those deployments. Finally, the system is used to produce statistics and reports about the Civilian Response Corps.

On the left-hand side of the screen, you will find a menu with different options. The first item to complete is "My Information" which will collect the basic information about your contact information, background and skills.

You will need a username and password to access the database. Please remember that the system contains very sensitive information and should not be shared with others who do not have access unless it has been approved by CSO/CRO.

PRIVACY ACT STATEMENT AND PAPERWORK REDUCTION ACT

AUTHORITIES: The information is sought pursuant to 22 U.S.C. §2734 (Reconstruction and Stabilization); 5 U.S.C. § 301 (Management of Executive Agencies); 22 U.S.C. § 2651a (Organization of the Department of State); 22 U.S.C. § 3921 (Management of the Foreign Service).

PURPOSE: The information collected and maintained in this form will be used to establish and maintain the Corps, to allow for ease in identifying the best fit of personnel for specific missions, and, in the case of applicants not immediately selected but still of interest for future selection into the Corps, to maintain a database of potential candidates for the Corps.

Members' social security numbers will be used for the purpose of security checks and to obtain access to military facilities, including manifesting on military aircraft.

ROUTINE USES: The information will be shared with participating agencies and will be used to manage and select individuals who have been hired or agreed to deploy overseas in support of Conflict Prevention and Stabilization efforts of the U.S. Government. The information regarding readiness to deploy and subject matter expertise will be shared with other participating federal agencies for the purpose of determining which members are available and best qualified for a particular mission. More information on the Routine Uses for the system can be found in SORN-68.

***BURDEN:** Public reporting burden for this collection of information is estimated to average 60 minutes per response, including time required for searching existing data sources, gathering the necessary documentation, providing the information and/or documents required, and reviewing the final collection. You do not have to supply this information unless this collection displays a currently valid OMB control number.
