

Supporting Statement A
Designation of Attorney In Fact
(Form I-312)
OMB No. 1653 - 0041

A. Justification:

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

Section § 103.6 of the Immigration and Nationality Act, provide for the posting of surety bonds. All surety bonds posted in immigration cases shall be executed on Form I-352, Immigration Bond, and secured with form of collateral by an Obligor. The Obligor can designate a third party as an Attorney in Fact to accept on their behalf the return of the collateral security deposited to secure the surety bond upon cancellation of the bond or performance of the Obligor. The form I-312, Designation of Attorney in Fact, is the instrument used by the Obligor to officially designate their Attorney In Fact with an ICE Field Office Director who is authorized to approve the request for delivery of the collateral security.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

The data collected on this form is used by USICE to ensure that the Field Office Director is presented an official request for delivery of collateral security to a duly appointed Attorney In Fact for an Obligor when the Obligor chooses to invoke this option.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

The use of this form provides the most efficient means for collecting and processing the required data. In this case, ICE does not employ the use of information technology in collecting and processing this information.

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

A review of the Forms Inventory Report revealed no duplication of effort, and there is no other similar information currently available which can be used for this purpose.

This collection of information does not have an impact on small businesses or other small entities.

Sections 103.6, 236 and 240B of the Immigration and Nationality Act (INA) provides for the acceptance of bonds in certain cases. The failure to provide the mechanism for the cancellation of bonds would be a violation of that section of law. USICE has always taken the position that the use of bonds is an integral part of the detention strategy.

7. **Explain any special circumstances that would cause an information collection to be conducted in a manner:**

- **Requiring respondents to report information to the agency more often than quarterly;**
- **requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**
- **requiring respondents to submit more than an original and two copies of any document;**
- **requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;**
- **In connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;**
- **requiring the use of a statistical data classification that has not been reviewed and approved by OMB;**
- **that includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or**
- **requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.**

The special circumstances contained in item 7 are not applicable to this information collection.

On 6/14/2012, USICE published a notice in the Federal Register at 77 FR 14522, soliciting public review and comment for a 60-day period on the proposed extension of this information collection. USICE received no comments during this period. On 9/10/2012 USICE published a follow up notice in the Federal Register at 77 FR 20315 soliciting public review and comment for an additional 30-day period. USICE has received no comments during that 30-day period.

9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

ICE does not provide payments or gifts to respondents in exchange for a benefit sought.

There is no assurance of confidentiality.

The projected hours per response for this collection of information were derived by first breaking the process into three basic components:

Learning about the Law and the Form:	10 Minutes
Completion of the Form:	10 Minutes
Assembling and Filing the Form:	10 Minutes
Total Hours per Response:	30 Minutes

Annual Reporting Burden

Total annual reporting burden hours is 6,250. This figure was derived by multiplying the number of respondents (12,500) x frequency of response (1) x (0.5) hours per response.

Annual Cost Burden

The estimated annual cost burden is \$ 62,500. This estimate is based on the number of respondents (12,500) x number of responses (1) x hours per response (0.5) x (\$10) average hourly rate;

Government Cost

The estimated cost of the program to the Government is calculated by subtracting the Total Cost of Program from the Fee Charge. Total Cost of Program is calculated by the estimated number of respondents (12,500) filing the Designation of Attorney in Fact, multiplied by four (4.0) hours (Time required to collect and process) x \$40 (Suggested average hourly rate for clerical, officer, and managerial time with benefits, plus a percent for the estimated overhead cost for printing, stocking, distributing and processing of this form).

This is an existing collection; therefore there is no increase or decrease in the burden hours previously reported for this information collection.
