Your Burial Benefits

As a Veteran, you may be eligible to be buried in a national or state Veterans' cemetery. Burial benefits include a gravesite in one of the 131 national Veteran's cemeteries or one of the 81 state Veterans' cemeteries, opening and closing of the grave, perpetual maintenance of the gravesite, a government-provided headstone or marker, a U.S. flag, and a Presidential Memorial Certificate. These benefits are available at no cost to the family and apply to both casketed and cremated remains.

Your spouse and/or dependents may also be eligible to be interred with you in a shared gravesite at a national/state Veterans' cemetery. This benefit includes burial with the Veteran, perpetual maintenance of the gravesite, and their names and dates of birth and death inscribed on the Veteran's headstone, at no cost to the family.

Some Veterans may also be eligible for a Burial Allowance, a partial reimbursement of an eligible Veteran's burial and funeral costs. When the cause of death is not service-related, the reimbursement generally consists of two parts: (1) a burial and funeral expense allowance, and (2) a plot or interment allowance.
