Your tax treaty exemption claim for reduced tax withholding under a treaty between your country of residence for tax purposes and the United States will soon expire. If you do not wish to renew your tax treaty exemption claim, you do not need to take any action.

If you wish to renew your tax treaty exemption claim, read the enclosed Form TB-125, *Completion Instructions For Form RRB-1001, Nonresident Questionnaire*. Use the instructions to complete the attached Form RRB-1001. You must provide a United States taxpayer identifying number in item B. **Do not provide a social security or social insurance number issued to you by a country other than the United States.** See Form TB-125 for action to take if you do not have a United States number. If you wish to renew your tax treaty exemption, you must do all of the following:

- (1) Furnish your United States taxpayer identifying number in item B, and
- (2) Enter your claimed country of residence for tax purposes in item 2, and
- (3) Check the tax treaty exemption claim box "YES" in item 3, and
- (4) Sign and date the form in item 5, and
- (5) Use the envelope provided to return the completed form to the office shown on the back of Form RRB-1001. Be sure the address shows through the window portion of the envelope.
