**Justification**

CBP Form 3078, *Application for Identification Card*, is filled out in order to obtain an Identification Card which is used to gain access to CBP security areas. This form is usually completed by licensed Cartmen or Lightermen whose duties require receiving, transporting, or otherwise handling imported merchandise which has not been released from CBP custody. This information is needed to determine if an employee may be admitted to a CBP secure area.

This information is not duplicated in any other place or any other form.

There is no offer of a monetary or material value for this information collection.

A SORN for Persons Engaged in International Trade (Vol. 73, Page 77753), dated December 19, 2008 has been included in this ICR. There are no assurances of confidentiality provided to the respondents of this information collection.

**Public Cost**

The estimated cost to the respondents is \$849,000. This is based on the estimated burden hours (42,450) multiplied (x) hourly rate (\$20.00).

**13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information.**

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

**14. Provide estimates of annualized cost to the Federal Government. The estimated annual cost to the Federal Government associated with the review of these responses is **\$6,300,000**. This is based on the number of responses (150,000) that must be reviewed (x) the time to review and process each response (1 hour) = 150,000 hours (x) the average hourly rate (\$42.00) = \$6,300,000.

**15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13 of this Statement.**

There has been no increase or decrease in the estimated annual burden hours

previously reported for this information collection. There is no change to the information collected or to CBP Form 3078.
