PURPOSE:** This survey will evaluate the effectiveness of the consumer communications developed for the Consumer Financial Protection Bureau (CFPB) and its tools, specifically the Owning a Home tool and Consumer Response. This research will allow the CFPB to quantitatively select the most effect messaging and visual creative to drive positive brand awareness of the agency and increased usage of the agency's consumer tools.

The researchers will recruit participants using pre-recruited national online panels. Respondents will be screened to be in between the ages of 25 and 65, with a minimum of 400 being between the ages of 30 to 44. All respondents will be screened to either be the sole financial decision-maker or share financial decision-making in their household.

The recruiting of survey respondents is subcontracted by GMMB and Applied Research & Consulting (ARC) to independent panel companies. These companies own and manage proprietary, national databases of potential respondents who have opted in to participate in surveys. At no point in the process will ARC, GMMB or CFPB have access to the respondents' names, mailing addresses, email addresses, phone numbers or any other information that would make it possible to identify or contact the individuals. ARC, GMMB and CFPB will only have access to the demographic, attitudinal and behavioral category data that comprise the contents of the survey questionnaire.
