To identify the reasons these members enrolled in the program so outreach messages can be improved, if necessary; and 3. To identify new ways to do outreach to potential members, such as social media web sites.

DESCRIPTION OF RESPONDENTS:

They are members of the WTC Health Program GRC who performed rescue, recovery, clean-up and other activities after the 9/11 attacks. The Outreach Survey will be given to them when they come to the program for their first medical monitoring examination at four of the five Clinical Centers of Excellence in the WTC Health Program GRC. One of the Clinical Centers of Excellence has chosen to administer the survey by phone after the first medical monitoring examination.

Under a previous genIC, we estimated that 899 Program members would take the survey during an initial medical monitoring exam with the WTC Health Program GRC. This number is based on the number of clinic visits from March 1, 2012 through February 28, 2013. We also estimated that 420 members would take the survey via a phone. This number is based on average monthly initial medical monitoring visits since July 1, 2012. We indicated that this survey would be conducted in multiple languages due to the clinics' diverse populations and that the translated versions of this survey will be sent to OMB when available. Per OMB, although the current genIC accounts for the burden of all of the translations (English, Spanish, and Polish), a new genIC is required for the transmission of the Spanish and Polish instruments. The translated versions will be conducted via a paper-based survey.
