The Bureau of Economic Analysis (BEA) strongly supports the continued collection of data on Forms SHC and SHCA. The data collected on these forms are crucial to key components of BEA's economic statistics.

Annual and benchmark reports on U.S. residents' holdings of foreign securities are used directly in compiling estimates for BEA's International Investment Position (IIP). Specifically, these reports contribute to estimates on several lines of IIP Table 1 and Table 2, including lines 19-21 (foreign bonds and foreign stocks). These reports also serve as a check on quarterly estimates and as a guideline to annual revisions of those estimates in BEA's International Transactions Accounts (ITAs). In particular, these reports impact estimates on several lines of ITA Table 1, including line 52 (foreign securities) and line 15 (other private receipts), as well as estimates in Section A of ITA Table 8.

In addition, the reports provide analytical background information regarding BEA's estimates for commercial paper, which is included in ITA Table 1 line 24 (U.S. bank claims) and estimates in ITA Table 9. The attachment below shows the data used by BEA and how they are used.

Please keep BEA informed about any modifications to these forms. We are particularly interested in any modifications proposed during the forms' approval process that would substantially affect our use of these data.
