The Assistance to Firefighters Grant Program project is a competitive grant opportunity that is administered by the Assistance to Firefighters Program Office. The grant application package is included in the Office of Management and Budget Information Collection Request 1660-0054. The purpose of the application is to assess the needs of each individual applicant compared to the other applicants interested in the opportunity. The authority for Assistance to Firefighters Grant Program (AFG) is derived from the Federal Fire Protection and Control Act of 1974 (15 U.S.C. §§ 2229 et seq.), as amended. This submission is necessary in order for DHS to effectively implement a competitive grant program and meet the fiscal deadlines. The data generated through the grant application process is stored and maintained in the AFG-Assisted Firefighter Grant IT system, which was de-coupled from the National Emergency Management Information System (NEMIS). This system does not relate to any other grant application system such as National Disaster (ND) Grants. Applicants are state, county, and municipal organizations/entities in charge of administering fire fighting duties.
