

**Supporting Statement**  
**Declaration for Free Entry of Returned American Products**  
**1651-0011**

**A. Justification**

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

CBP Form 3311, *Declaration for Free Entry of Returned American Products*, is used by importers and their agents when duty-free entry is claimed for a shipment of returned American products under the Harmonized Tariff Schedules of the United States. This form serves as a declaration that the goods are American made and that (a) they have not been advanced in value or improved in condition while abroad, (b) were not previously entered under a Temporary Importation Under Bond provision, and (c) drawback was never claimed and/or paid. CBP Form 3311 is authorized by 19 CFR 10.1, 10.5, 10.6, 10.66, 10.67, 12.41, 123.4, 142.11, 143.21, 143.23, 143.25 and is accessible at [http://forms.cbp.gov/pdf/CBP\\_Form\\_3311.pdf](http://forms.cbp.gov/pdf/CBP_Form_3311.pdf)

This collection of information applies to the importing and trade community who are familiar with import procedures and with the CBP regulations.

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection .**

CBP Form 3311 is used by importers and their agents to obtain duty free treatment on returned American goods. CBP uses the information collected on this form to substantiate duty free claims.

- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. CBP Form 3311 must be submitted manually because it requires a signature from a CBP officer at the port and it must be submitted in duplicate as required by 19 CFR 10.1.

This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

If CBP Form 3311 was not filed, importers would not be able to substantiate a claim for duty-free treatment on returned American goods.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices published on September 21, 2012 (Volume 77, Page 58564) and on December 11, 2012 (Volume 77, Page 73672) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

There is no assurance of confidentiality provided to respondents. A PIA for the Automated Commercial System (ACS) dated December 2, 2008, and a SORN for ACS/ACE, dated December 19, 2008 (Vol. 73, Page 77759) will be included in this ICR.

**Public Cost**

The estimated cost to the respondents is \$840,000. This is based on the estimated burden hours (42,000) multiplied (x) hourly rate (\$20.00)

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

The estimated cost to the Federal Government for collecting, analyzing and processing this information collection is \$1,464,120. This is based on total responses (420,000) multiplied by time spent per response (5 minutes or .083 hours) = 34,860 hours multiplied (x) an average hourly rate of \$42.00= \$1,464,120.

- 15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13.**

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There is no change to the information collected or to CBP Form 3311.

This information collection will not be published for statistical purposes.
