FEDERAL COST: The estimated annual cost to the Federal government is <u>approximately</u> \$371. These costs assume a 20% participation of the 800 federal users who are sent the survey. 20% X 800 = 160. The breakdown of costs are as follows:

- One employee spends 5 minutes, costing \$2 (based on GS11 rate of \$24 per hour), to respond to the survey. If 160 users respond, the total participation time would be 13.3 hours. 13.3hrs x \$24 = \$320
- Three employees spend 30 minutes, costing \$17 each (based on GS13 rate of \$34 per hour) to review the survey. 1.5hrs x \$34 = \$51

Total cost = \$371 annually
