FEDERAL COST: The estimated annual cost to the Federal government is \$60/year.

It is estimated that there will be approximately 17 IHS Pharmacy Residents each year. The resident will complete the survey at the start of the rotation and at the end of the rotation. One person would spend about 5 minutes on each survey reviewing the responses and collecting the information. 34 responses x 5 minutes=170 minutes/year or 2.8 hours/year. A GS 9 rate of about \$20/hour x 2.8 hours is \$56/year
