

## I. Internal Automated Scheduling Screen Flows

### Introduction

The screens presented in this package only include screens used by SSA employees in the hearing offices (HOs) to record information they obtain directly from the public through a telephone or in-person interview process. The internal Automated Scheduling Application (ASA) includes additional screens, which are not presented for OMB approval, which the HOs use to perform back-end scheduling functions.


### Profile

An HO invites each AR or Expert to the HO to receive assistance in completing or reviewing his or her profile before accessing the external ASA. The profile collects general information about the user that determines the availability choices presented to the user and provides information for the internal scheduling batch engine to propose hearings in which the user can participate. The HO edits the default profile using the internal ASA profile screens. If experts (other than Verbatim Hearing Recorders (VHR)) need to change their profile after the initial visit, they may do so through the external ASA or by visiting or calling the HO who edits the profile using the internal ASA screens. VHRs cannot edit their profile through the external ASA so they will need to contact the HO.

## Monthly Calendar

## Daily Calendar
