Guarantee of Payment

**A. Justification**

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

Section 253 of the Immigration and Nationality Act (INA) requires that an alien crewman found to be or suspected of being afflicted with any of the diseases named in section 255 of the INA shall be placed in a hospital for treatment and/or observation with the expense of such observation and/or treatment being borne by the carrier. The guarantee of payment for medical and other related expenses required by section 253 of the Act shall be executed by the owner, agent, consignee, commanding officer or master of the vessel or aircraft on CBP Form I-510, *Guarantee of Payment*. No vessel or aircraft can be granted clearance until such expenses are paid or the payment is appropriately guaranteed.

CBP Form I-510 collects information such as the name of the owner, agent, commander officer or master of the vessel or aircraft; the name of the crewman; the port of arrival; and signature of the guarantor. The information on CBP Form I-510 is used by CBP to help ensure that expenses of caring for an alien crewman are reimbursed by the carrier.

This form is filled out at a port of entry so it would not be appropriate to submit it electronically. Also, it requires an original signature of a guarantor and of a CBP officer.

This information is not duplicated in any other place or any other form.

This information collection does not have an impact on small businesses or other small entities.

CBP Form I-510 is used to help ensure compliance with Section 253 of the Immigration and Nationality Act that requires the owner, agent, consignee, commanding officer, or master of the vessel or aircraft incur the expense of caring for an alien crewman afflicted with a disability or disease. Without this form, CBP could not carry out these provisions of the Act.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices published on October 31, 2012 (Volume 77, Page 65899) and on January 8 (Volume 78, Page 1220). No comments were received.

There is no offer of a monetary or material value for this information collection.

A SORN was published on December 18, 2008 (Volume 73, Page 68435) for passenger lists and crew lists. A copy of this SORN will be submitted with this ICR.

There are no assurances of confidentiality provided to the respondents of this information collection.

**Public Cost**

The estimated cost to the respondents is \$160. This is based on the estimated burden hours (8) multiplied (x) the estimated hourly rate (\$20.00).

The estimated annual cost to the Federal Government associated with the review of these records is **\$336**. This is based on the number of responses (100) that must be reviewed (x) the time to review and process each response (5 minutes or .083 hours) = 8 hours (x) the average hourly rate (\$42.00) = \$336

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection and there are no changes to the information collected or to CBP Form I-510.
