### United States Department of Energy Supporting Statement Foreign Travel Management System OMB Control Number 1910-5144

This supporting statement provides additional information regarding the Department of Energy (DOE) request for processing of the travel information collection, Foreign Travel Management System. The numbered questions correspond to the order shown on the Office of Management and Budget (OMB) Form 83-1, "Instructions for Completing OMB Form 83-1."

#### A. Justifications.

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate action of each statute and regulation mandating or authorizing the collection of information.

Department of Energy (DOE) Order 551.1D, "Official Foreign Travel" dated April 2, 2012, as prescribed in 48 CFR 947.247-70 Foreign travel, mandates the collection of information for DOE foreign travel. The order vests the responsible Program Secretarial Officers with executive direction and management function, authority, and responsibilities of the accountability for all foreign travel conducted under their authority for both Federal employees and contractors. Over 21,000 foreign trips are conducted on an annual basis essential to DOE's mission and objectives. The information collected is used to secure country clearances required by the Department of State, passports, and Visas which grants country clearance and the issuance of passports and visas. This collection ensures that DOE will be able to track travel expenditures to respond to General Accounting Office, and/or the Office of Management and Budget foreign travel inquires.

2. <u>Indicate how, by whom, and for what purpose the information is to be used.</u> Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

The information collected will be used by Programmatic Secretarial Officers, Program Managers, and Heads of Organizations to manage their program objectives in order to accomplish DOE's missions, this system will ensure that all travel requests are tracked and Federal and DOE requirements are met and that travel costs are minimal and do not exceed allocated funds. FTMS is the only DOE-wide system whereby the Program Offices are able to view travel costs for Federal employees and contractors.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

All foreign travel information is collected through the Department's centralized webbased Foreign Travel Management System (FTMS) at <a href="https://ftms.doe.gov">https://ftms.doe.gov</a> which will reduce the burden of data collection.

4. <u>Describe efforts to identify duplication</u>. <u>Show specifically why any similar information already cannot be used or modified for use for the purposes described in Item 2 above.</u>

The Foreign Travel Management System (FTMS) is unique to DOE and there is no other system to our knowledge of its kind in existence. As a centralized web-based system, it collects federal and contractor travelers' information for DOE at approximately 160 sites. There are no other centralized systems that gather this specific information which allows DOE Headquarters to have access at a moment's notice to the whereabouts of its travelers when an emergency arises. This system was built based on DOE's business requirements and is not available from any other source and is not duplicated elsewhere to our knowledge.

5. <u>If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.</u>

As this collection applies only to DOE federal and contractor personnel, small businesses are not impacted by the collection of this data.

6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

If this collection is not conducted, effective oversight and management of Department foreign travel activities would not be possible. DOE conducts over 21,000 foreign trips annually, and it would be a major impact on the ability to accomplish DOE missions as the information collected is used to secure country clearances required by the Department of State, passports, and Visas which grants country clearance and the issuance of passports and visas. If the information is not collected, travel would not be granted and the missions and objectives the Department of Energy would not be accomplished.

7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines. (a) requiring respondents to report information to the agency more often than quarterly; (b) requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it; (c) requiring respondents to submit more than an original and two copies of any document; (d) requiring respondents to retain records, other than health, medical government contract, grant-in-aid, or tax records, for more than three years; (e) in connection with a statistical survey, that is not designed to product valid and reliable results that can be generalized to the universe of study; (f) requiring the use of statistical data classification that has not been reviewed and approved by OMB; (g) that includes a pledge of confidentially that is not supported by authority established in stature of regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; (h) requiring respondents to submit proprietary trade secrets, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

There are none. The information collection is not being conducted in a manner inconsistent with OMB guidelines.

The Department published a 60-day Federal Register Notice and Request for Comments concerning this collection in the Federal Register on June 11, 2012, volume 77, number 112, page 34367. No comments were received.

9. Explain any decision to provide any payment or gift to respondents, other that remuneration of contractors or grantees.

No payment or gift to respondents is being proposed under this information collection.

## 10. <u>Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.</u>

FTMS goes through DOE's Certification and Accreditation (C&A) process annually to ensure that the system follows government and DOE's guidelines in regard to data protection. Two-factor authentication is used for sensitive information, i.e. passport scans, date of birth.

No questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs are included in this information collection.

The estimate of hour burden of the information collection is as follows:

Total number of respondents is: 2,230 Total number of responses is: 9,666

Total number of annual responses is: 21,555

Total reporting burden per response per hour is: 0.15

Total annual burden hours: 5,389

Frequency of response: Based on the number of trips taken by the respondent during the year.

The total number of burden hours was determined by averaging the amount of time it takes to collect and enter the information into the database by the respondent which could be the traveler or the travel arranger. The average time to enter a trip into the system is 15 minutes which includes securing approval of the travel which equates to 5,389 burden hours.

FTMS is the system of record maintained within DOE programs; therefore, there is no cost to the respondents

#### 14. Provide estimates of annualized cost to the Federal government.

Cost to maintain the travel system is \$360,000 annually and \$90,000 for licensing fees. Total annual cost: \$450,000

# 15. Explain the reasons for any program changes or adjustments reported in Item 13 (or 14) of OMB Form 83-I.

FTMS' contract costs are \$450,000 a year to maintain, operate, and develop the system including other direct costs such as housing the services and license fees. Due to an increase of approved foreign travel, the number of responses and burden hours has increase accordingly

Total difference in responses: 4,643 Total difference in burden hours: 1,161
