Arts Education Managers' Professional Development Institute Evaluation

**PURPOSE:**

The purpose of this information collection is to evaluate the effectiveness of the Arts Education Managers' Professional Development Institute (PDI), a national training program offered on an annual basis. For more than 20 years, the National Endowment for the Arts and NASAA have collaborated to offer the PDI in order to provide leadership development and technical assistance for state arts agency arts education managers.
