NASAA Partnership Data Portal Project **Web Survey**

Introduction

Information is being collected to assess the feasibility of creating an online system (the "Portal") to report Final Descriptive Report (FDR) data to the NEA and NASAA and to study ways to make the process of FDR reporting more streamlined, robust and timely. The information will be used to assess whether such an online system is feasible, and if so, to recommend potential options and specifications for such a system. The exploration of the feasibility of a potential Portal is in no way associated with any current federal reporting systems such as grants.gov.

We estimate the time required to fill out the following web-based survey will be fifteen (15) minutes.

Participation is voluntary. We do believe there is a benefit for the survey respondents or their organizations. The Portal, if implemented, should make reporting FDR data simpler, faster and with fewer errors. Also, the system might have additional features that would facilitate the sharing of information internally as well as with the public once implemented.

The data gathered from this survey will be shared with the NEA and NASAA. About 30-60 days after the survey's release, we will share the findings of the feasibility study and present the concept for the online system through a web seminar or similar method. All of the survey respondents will be invited to participate and give feedback, although this will not be required.

No sensitive information is being requested.

Basic "Portal" Concept

The NEA and NASAA are studying ways to improve the FDR reporting process. The concept presently under consideration is an online "Portal" to allow you to submit the data into a web-based system instead of sending the information through e-mail as an attached file or through mail copied onto a disk.

Here is -theoretically- how a portal could work:

- Your agency would be given an account on the Portal whereby you could sign-in and upload the data file you presently mail to the NEA and NASAA.
- The Portal would perform certain minimum data validation checks and flag potential errors found in the data. You would be able to review and change the data as appropriate. You would also be able to view the data in certain standard tabular formats.

- Possibly, some data visualization options, such as mapping and bar charts, could be available to you, if the data met certain validation thresholds.
- After having a chance to review your data through the standardized checks, tables and charts/maps, an appropriately authorized user would be able to submit the dataset to the NEA and NASAA by clicking a button.

Would it be useful, on an optional basis, to include additional information in the FDR reporting process, such as the program name of the individual grant record or the name of the grant officer responsible for the individual grant record? This optional information would not be passed on as the part of the final FDR report but would be used to help you review the data for accuracy.

- Pie charts [Options should have either fields next to each into which the user could enter rank numbers, or drop-down menus containing possible rank numbers.]
 - Grants by program name
 - Grants by institution type
 - Grants by type of activity
- Multi-year trend analysis [Options should have either fields next to each into which the user could enter rank numbers, or drop-down menus containing possible rank numbers.]
 - Total number of grants made over past years
 - Total grant amounts made over past years
 - $\circ\quad$ Number of grants and total grant amounts by program name over past years
 - o Similar multi-year trend analysis against a composite index of comparable states
 - Similar multi-year trend analysis against a national benchmark index

- 11. If you uploaded records to the Portal, and it identified blank fields or other data errors, how helpful would the following types of data reviews be before submission to the NEA and NASAA?  - Email the relevant grant officer his or her relevant records to review and update the data.
 - Print out the relevant records, highlighting the potential need for updating.
 - View the relevant records on screen in a table with the relevant fields highlighted. Each
 highlighted area in the table would allow you to click through to view the detailed record
 and allow you to update that record.
