NEA maintains a database of all grantees and from this, 8 grantees from with exhibitions in March-April 2012 will be selected. The grantees will be administering the survey to their audiences. At each event, it is anticipated that on average 200 attendees will receive the survey. Both a paper-based and online questionnaire will be piloted. Essentially the same questionnaire will be used for all categories of audiences, but the wording will be tailored for the event. The versions of all questionnaires, both paper and online versions, for all categories are included in this request.
